Transport Canada - Environmental Affairs has reviewed the *Nunavut Water Board Preliminary Guidelines for Applicant* and has the following comments that will pertain to projects in Nunavut;

Point # 3.0 Additional Documents to Assist the Applicant

The Proponent should be guided by and directed to the following standards/guidelines/acts that are applicable to the Transport Canada - Navigable Waters Protection Program (NWPP) and the Navigable Waters Protection Act (NWPA). NWPP is the Federal Authority mandated with enforcing the NWPA. All proponents must deal directly with NWPP for any work(s) to be built or placed in, on, over, under, through, or across any navigable water. The proponent will need to submit formal applications to the NWPP in order to obtain NWPP's approval, promulgation, or exemption for each specific work. The proponent shall also inform the NWPP of any design, construction, or operational changes accordingly. If the proponent is uncertain of the NWPP's requirements as they pertain to an application for a specific work, please refer to the NWPP Internet site or contact the NWPP office.

Under the Nunavut Water Board (NWB), it is the Proponent's responsibility to ensure that all necessary standards and guidelines, are considered in their water license applications. In addition, the Proponent will also be responsible to provide formal applications to the NWPP for any works.
