Can the public hearing record on Agnico Eagle Mines Ltd's application to amend and renew the type A water licence for their Meadowbank Gold Project remain open until 5 p.m. EDT/3 p.m. MDT on Tuesday May 26, 2015? The current deadline for providing additional written materials to the Nunavut Water Board is 3 p.m. MDT on Friday May 22, 2015. Yesterday afternoon Aboriginal Affairs and Northern Development Canada received a technical memorandum from the Kivalliq Inuit Association regarding the allocation of land and water related liabilities. Additional time is needed to review this memorandum and provide a recommendation to the Nunavut Water Board regarding the amount of reclamation security that should be required under a renewed water licence.
