Please be advised that on January 11, 2013 Aboriginal Affairs and Northern Development Canada received the above-referenced Irrevocable Standby Letter of Credit as amended, January 7, 2013. This security instrument was submitted by Agnico-Eagle Mines Ltd. pursuant to Part C, Item 1 of the Meadowbank Gold Project's Type 'A' Nunavut Water Board licence, No. 2AM-MEA0815.

This licence term and condition states,

- 1. The Licensee shall furnish and maintain security with the Minister in the form that is satisfactory to the Minister, in the prescribed amounts:
 - a. Within thirty days of approval of this licence, an amount of \$26,000,000;
 - b. An additional amount of \$4,000,000 on January 1, 2010;
 - c. An additional amount of \$4,000,000 on January 1, 2011;
 - d. An additional amount of \$4,000,000 on January 1, 2012;
 - e. An additional amount of \$4,000,000 on January 1, 2013; and,
 - f. An additional amount of \$1,900,000 on January 1, 2014

for a total of \$43,900,000.



The Irrevocable Standby Letter of Credit, issued by Scotiabank, was amended to:

- Increase the credit by \$4,000,000 to a total of \$42,000,000; and,
- The beneficiary's address has been amended to Building 969, IQALUIT, NUNAVUT, CANADA, X0A 0H0 (formerly P.O. Box 100 Building 918, IQALUIT, NUNAVUT, CANADA, X0A 0H0).

This amendment is effective January 1, 2013.
