Hi Richard,

Thank you for forwarding the Dec. 2008 monitoring report. I noted that the sewage treatment plant effluent was not analysed for ammonia (just nitrate + nitrite) and would suggest this should be measured. At some point the ammonia balance will need to be reviewed, and this is a measurable source. Also, the Sewage Treatment Plant O&M manual specifies that ammonia will be tested:

Water quality sampling of the input and final discharges from the Seprotech and Biodisk RBC units is

conducted weekly. Water samples are tested for:

- Ammonia
- Biological Oxygen Demand (BOD5)
- Faecal Coliforms
- pH
- Total Suspended Solids
- Total Phosphate
