



NOTICE OF SITE VISIT

The Nunavut Impact Review Board (NIRB) will be attending a Site Visit at Agnico Eagle Mines Limited's (AEM) proposed Meliadine Gold Mine Project site. The Site Visit is taking place during the Final Hearing as part of the NIRB's Review of the ecosystemic and socio-economic impacts of the Meliadine Gold project proposal (NIRB File No. 11MN034) (the Project). The Site Visit will provide an opportunity for members of the NIRB, parties at the Final Hearing, members of the public and members of the media to increase their understanding and familiarity with the physical setting of the Project by getting a first-hand view of the proposed project development area and the general location of key project components as proposed by AEM.

Please note that during the Site Visit the NIRB will not be discussing any matters of substance associated with the NIRB Review of the proposed Meliadine Project with anyone. Subsequently, the NIRB will provide a Site Visit Report as an Appendix to the Final Hearing Report for the Project which will be available on the NIRB's public registry.

Details and Proposed Agenda:

The Site Visit will be conducted via bus tours on August 23, 2014. Owing to space limitations, the tour will be open to approximately 120 persons, with registrations to attend being accepted on a first come, first served basis. The tour will be conducted by AEM personnel, according to the agenda and details as set out below:

- Site Visit bus departures from the Rankin Inlet Community Hall at 8:00 a.m., 11:00 a.m., and 2:00 p.m. (40 persons per departure). Tours set to arrive back at the Community Hall for approximately 10:30 a.m., 1:30 p.m. and 4:30 p.m.
- Participants must adhere to instructions of AEM personnel, and must stay within designated areas at all times during the Site Visit.
- Participants should dress appropriately for weather conditions on the day of the Site Visit. No personal protective equipment is required, and no special clothing will be provided.
- Each tour will involve stops and explanations from AEM personnel at the following locations:
 - Along the all-weather access road at the Meliadine Bridge;
 - At the intersection of the existing all-weather access road and the proposed Discovery Road;
 - Near the existing portal facility;
 - Near the existing waste dump; and,
 - At the existing exploration camp.
