On August 1, 2014 the Nunavut Impact Review Board (NIRB or Board) distributed a draft agenda for the upcoming Final Hearing for its Review of Agnico Eagle Mines Ltd.'s (AEM or the Proponent) proposed Meliadine Gold Project (NIRB File No. 11MN034), requesting that interested parties review the document and provide the Board with their comments by August 8, 2014.
