Dear Parties:

On October 21, 2022, the Nunavut Impact Review Board (NIRB or Board) distributed the *Draft* Agenda for the November 22-25, 2022 Technical Meeting, Community Roundtable and Prehearing Conference to be held as part of the Board's assessment of Agnico Eagle Mines Limited's (Agnico Eagle or Proponent) "Meliadine Extension" Project Proposal (NIRB File No.: 11MN034). As part of the correspondence, the NIRB requested that interested parties confirm their planned attendance and provide comments or suggestions on the agenda.

The NIRB appreciates parties' interest in participating in the proceedings and that a spokesperson from each key department is available in person at the meetings. As the Board is returning to its normal procedures for holding in-person meetings, the NIRB would like to remind parties that questions may be deferred should experts not be available in the room. As well, parties are encouraged to discuss technical matters with each other and the Proponent outside of the process and provide any resolutions or commitments during the technical meeting.
