I am responding to the email you sent to Luis Manzo.

First of all, I wish to remind you of the KIA management protocol with respect to circulation of letters and emails from Agnico personnel that require approval from the executive of KIA. All mail and letters must be send to the following executive members:

This is very serious technical request from Agnico. First, the special request for protocol exemptions by expedited Nunavut Water Board approval to amend it's water license, technical amendments at Melaidine lake mine to say the least , is concerning. Secondly, the request violates NWB's public consultation protocol that Agnico first must carry out with the community interest groups in Rankin including KIA, HTO and Clarks.

The special request to dump CP1 saline water directly into the Meladine Lake if approved by Nunavut Water Board by May 1, 2020. I personally know the community of Rankin Inlet will not accept such a request. KIA will consult with the community groups soon and will contact you about your request to dump the saline water to Rankin Inlet's public water supply lake contrary to currently practice of dumping saline water delivery by water trucks to the ocean by way of Agnico roads.

KIA respectfully ask you to reconsider your request for exemptions for foregoing public consultation before asking for amendments to your current Water License from Nunavut Water Board.
