Hello Richard:

Thank you for the opportunity to comment. Agnico Eagle is sympathetic to and well aware of the challenges posed by Covid-19 to all participants.

Agnico Eagle does not object to the extension for submission of presentations etc. to April 14<sup>th</sup>, 2020 and would be willing to support moving the time of the teleconference on April 15<sup>th</sup> to a time later in the day (afternoon), in order to permit all parties the opportunity to review the presentations that would be submitted on April 14<sup>th</sup> and support an efficient meeting.

As this application is on an emergency basis, which has been communicated to multiple parties, plus the teleconference has already been delayed from April 8/9 to April 15<sup>th</sup>, Agnico Eagle strongly objects to the granting of KIA's request further delay to April 17<sup>th</sup>, 2020. Further procedural delay of the application is unreasonable and has risk of causing harm to infrastructure, which is not in the public interest. There was no objection to the original April 8/9 date that was proposed by the NWB that we were aware of.

On the topic of completeness of information, Agnico Eagle is of the view that the package filed on April 6 is complete. If KIA has additional information requests, then Agnico Eagle asks that KIA not wait until the teleconference to make such requests, and forward such requests as soon as possible directly to Agnico Eagle.
