Good morning,

Thank you for your inspection report. We have a few clarifying questions with regards to section 2:

- The box "Non-Compliance with Act or Licence" was checked off indicating that a non-compliance with respect to an act or licence condition was observed during the inspection. Would you kindly indicate to us which act/licence condition (item number and reference document) you are referring to? This will assist us to address the concern.

- Furthermore, the second point in Section 2 requests that *“The Licensee shall revise the Spill Contingency Plan to include a section on dust releases. This plan shall include a clear threshold for reporting dust releases. This plan shall be submitted to the inspector for review by January 7th, 2020. “*

AEM would kindly request that CIRNAC provides a threshold to be used in order to guide when dust releases should be reported. It is not clear to AEM what threshold should be used and it would be appreciated if CIRNAC could provide guidance on this based on experience in Nunavut with Mine project monitoring.
