The construction is more or less completed, there are a few things with the electrical programing that remain. All in all we will be ready in time to handle the freshet on site.

We are waiting on mother nature to help thaw some of the CP5 water so that we can begin commissioning of the unit. Obviously we can only begin that once we have water at our disposal.

The approvals for the OMM and Design Report were granted by the NWB.

We have identified our sampling locations and sampling plan, as well as how we will collect water to validate the quality prior to environmental discharge. The discharge tank which will collect CP1 water and treated CP5 water will be recirculated back to CP1 until we have confirmed results of the quality.
