Hi Robin,

Fisheries and Oceans Canada (DFO) has reviewed the April 2022 Waste Rock Storage Facility 3 South Sump Design Report and Construction Drawings.

DFO's understanding is that the design report is submitted in accordance with the June 2021 Type A Water Licence Amendment 2AM-MEL-1631 and subject to conditions of the Water Licence.

It is our understanding that the construction of the proposed structures will not occur in fish habitat but may affect fish habitat downstream by changing the local runoff patterns by directing meltwater and precipitation away from fish bearing ponds and away from existing mine infrastructure to mine wastewater treatment ponds. If effects to fish and fish habitat are observed, DFO should be contacted.

There is a *Duty to Notify* DFO if there has been or about to be, the death of fish by means other than fishing and/or the harmful alteration, disruption or destruction of fish habitat. Such notifications should be directed to <http://www.dfo-mpo.gc.ca/pnw-ppe/contact-eng.html>. Should the plans change or if some information has been omitted in the proposal, further review by DFO may be required. Consult our website (<http://www.dfo-mpo.gc.ca/pnw-ppe/index-eng.html>) or consult with a qualified environmental consultant to determine if further review may be necessary. It remains the Proponent's responsibility to remain in compliance with the *Fisheries Act*, the *Species at Risk Act* and the *Aquatic Invasive Species Regulations*.

With regard to the WRSF3 South Sump Design Report and Construction Drawings, DFO has no further comments.
