Hi Ian,

As the Lake A8 source is already an approved water source for industrial activities under 2BB-MEL licence, and also because of water quantities requested (3000 m3 annually) for a limited time, the Board was of the opinion that impacts on the water source could be minimal and was considering to use its authority without a formal amendment process as per Part E Item 1 that states:

The Licensee shall obtain all fresh Water for domestic camp use, mining and milling and associated uses, from Meliadine Lake at Monitoring Program Station MEL-01 using the Fresh Water Intake, or as otherwise approved by the Board in writing....
