Would you be able to let me know your timeframe after the meeting with consultants? We will have to ask all intervenors to confirm that their completeness IRs were satisfied once all info is in, especially taking into account QIA's letter.

So, while I can't give you a definite date, the sooner is the better. As you noted, the advantage is that we have a bit of a wiggle room since NWB's technical review period is 30 days.

The one recommendation is to make sure you copy all intervenors into the distribution of the updated documentation, as there may be some delays due to the holidays. That would ensure that all parties receive the updated info as soon as it is issued
