The Nunavut Water Board (NWB) notes that in December 16th the Nunavut Impact Review Board (NIRB) issued a procedural direction regarding next assessment steps of Baffinland Iron Mines Corporation's Phase 2 Development Proposal, stating that the NIRB has added additional process steps to allow for Baffinland and Intervenor to further the detailed review of technical issues during another in-person Technical Meeting (TM) (tentatively scheduled for five days to commence sometime in March)... Also noted, that the NIRB has directed that the scheduling of the continuation of the Hearing must await the outcome of the discussions of technical and procedural issues during the upcoming TM/PHC.

Based on this information the NWB is unable at this stage to provide specific dates, locations, agendas and other details for its Technical Meeting. The NWB will update Parties once details for continuation of NIRB Hearing become available.
