CIRNAC Has been working on our comments for the NWB with respect to Baffinland's application for a renewal license.

However we note that there are two documents that were referenced within the application package that we have not yet been able to locate and were wondering if you may be able to either provide or guide us to where we could find them:

1. **ERP FEIS** – we of course have the FEIS as well as its addendum, but we have also seen many separate references within the renewal application specifically to the "ERP FEIS". Presumably this refers to Early Revenue Phase FEIS, and it appears to be a preliminary version of the FEIS, but we have not been able to locate the document to check the references from the application. It is possible that the references to ERP FEIS within the application are identical to their respective sections in the FEIS, but without being able to verify, we wanted to check with you in case you had any further information.

3. **150203 2AM-MRY1325 H349000 4720 50 124 0002 Part1-IAAE.pdf** – this document is referenced within the application in several places, in particular in sections referring to water use and water management. We have (so far) been unable to locate it on the NWB FTP site.

As these documents are referenced in the application but can not be located on the NWB's FTP site we would ask that Baffinland provide them directly as soon as possible to avoid any delays in the processing of their application.
