The Nunavut Water Board requests Baffinland Iron Mines Corporation (BIMC) respond by Friday January 11, 2018 to comments received on BIMC Information Requests Responses, copies attached.

The NWB acknowledges that the Qikiqtani Inuit Association may have concerns with the coordinated review process.

The NWB encourages BIMC to work directly with interveners to address issues and clarify their position, as parties are aware BIMC had requested a coordinated review process with NWB and the NIRB, and the NWB has so far coordinated its actions with NIRB towards a joint technical meeting in March. If in the opinion of the interveners the application is not complete, the NWB will not be able to post notice of application and proceed towards a full technical review stage in a timely manner that may make it impossible for a joint NWB/NIRB technical meeting.
