### **Transportation to/from the Airport and Meetings**

Upon your arrival in Igloolik, the NIRB will arrange for you to be picked-up from the airport and dropped off to your billeting home, unless you have made other arrangements with your billeter.

You are responsible to get from your billeter's home to the meetings being held at the Community Hall on your own. The NIRB will not be providing transportation to/from meetings. If you require transportation assistance (for Elders, persons with disabilities), please let the NIRB know as soon as possible.

Per Diem cheques will be given out at the meeting on Sunday, November 6, 2011. The NIRB recommends that community representatives bring Photo Identification with them in order to have their cheque endorsed and cashed once in Igloolik.

### **Information Meeting - Saturday, November 5, 2011**

This meeting will also be an opportunity for representatives from the different communities to meet one another.

During the **Community Roundtable** session, Baffinland will provide you with information about their proposed Mary River project. You will have an opportunity to ask Baffinland questions about the proposed Mary River mine and other activities, and to express your thoughts about the proposed Mary River Project to the NIRB staff and Chairperson. It is essential that you are present at this meeting. Simultaneous interpretation in Inuktitut will be available during this session.

Before the start of the Pre-Hearing Conference, everyone at the Community Hall will be asked to sign-in, including each community representative and all other people attending. The NIRB will make sure that paper copies of the presentations are available, along with translated summaries of information from Baffinland, government agencies, and the Qikiqtani Inuit Association. The Pre-Hearing Conference will be more formal than the Community Roundtable sessions. Following the presentations given by Baffinland, the government agencies and the Qikiqtani Inuit Association, time will be allowed for you to ask Baffinland, the government agencies, or the Qikiqtani Inuit Association questions about the information presented.
