Re: Agenda for the Final Hearing for the NIRB's Review of Baffinland's Mary River project proposal

Dear Parties,

On June 26, 2012 the Nunavut Impact Review Board (NIRB or Board) distributed a draft agenda for the upcoming Final Hearing for the NIRB's Review of Baffinland Iron Mines Corp.'s Mary River project proposal, requesting that interested parties review the document and provide the Board with their comments by July 3, 2012. On July 3, 2012 the NIRB received correspondence from the Northern Projects Management Office, sent on behalf of various federal government departments and agencies, requesting an extension to Monday, July 9, 2012 for this comment deadline. In an effort to ensure all parties had adequate time to assist with the ongoing preparations for the Final Hearing, the NIRB subsequently extended the deadline for comments on the draft agenda to Friday, July 6, 2012.

Comments regarding the agenda for the upcoming Final Hearing have now been received from Baffinland Iron Mines Corp., the Government of Nunavut, the Qikiqtani Inuit Association and the Northern Projects Management Office; all comment submissions can be accessed online from the NIRB's public registry at the following location:

The NIRB appreciates the efforts by all parties to date in preparation for the upcoming Final Hearing and looks forward to continuing constructive discussions at the Final Hearing for the Mary River project proposal.
