As you are aware, on November 12, 2013 the Nunavut Impact Review Board requested that interested parties provide Final Written Submissions for the Public

Hearing that is set to be held January 27-31, 2014 in Pond Inlet as part of the NIRB's consideration of Baffinland Iron Mines Corp.'s Mary River Early Revenue Phase proposal. Further, on December 16, 2013 the NIRB distributed notice granting Intervenor Status for the Public Hearing to the Mittimatalik Hunters and Trappers Organization, the Hamlet of Pond Inlet, and IsumaTV.
