Re: Draft Agenda for the NIRB's Marine Monitoring and Marine Mitigation Workshop in Pond Inlet for the Mary River Project (NIRB File No. 08MN053), May 1-2, 2019.

Dear Parties:

On February 15, 2019 the Nunavut Impact Review Board (NIRB or Board) issued notification regarding the upcoming Marine Monitoring and Marine Mitigation Workshop to be held as part of the Board's monitoring program for Baffinland Iron Mines Corp.'s approved Mary River project (NIRB File No. 08MN053). The workshop has been scheduled for May 1-2, 2019 at the Atakaalik Community Hall, Pond Inlet with focused discussions from 9:00 am to 5:00 pm daily and a planned evening session for May 1 from 6:30-9:00 pm with a more open question and answer format. The objective of the workshop is to allow for direct involvement of the Qikiqtani Inuit Association (QIA), the Mittimatalik Hunters and Trappers Organization (MHTO), the Hamlet of Pond Inlet and interested residents of Pond Inlet in the review of project monitoring data, including but not limited to information collected under community-based monitoring programs.

The workshop will be structured to facilitate informal, face-to-face discussions of projectspecific shipping activities and associated monitoring and mitigation measures, specifically their effectiveness and application to the recently-approved production increase for the Mary River project. The workshop will be facilitated by NIRB staff and will provide opportunity for the Proponent to present a summary of its current monitoring and mitigation program for the marine environment, including community-based monitoring programs, followed by discussions between the Proponent, community members and community organizations, responsible authorities and other interested parties. Break-out sessions facilitated by NIRB staff may also be utilized to further discuss specific agenda items in smaller groups if necessary (e.g., marine mammal monitoring, vessel management protocol, marine environment working group etc.).

The NIRB has made the following arrangements for the Marine Workshop:

Interpretation: Simultaneous English and Inuktitut interpretation will be provided to

the extent practicable.

Facilitator: The meeting will be facilitated by Ryan Barry, NIRB Executive

Director.

Materials: Participants will be asked to make available printed/digital copies of

presentations or other information prepared for the workshop.

Meeting times: The workshop will begin at **9:00 am** each day and will run until **5:00**

pm, with an hour break for lunch and up to two 15-minute health breaks each day. Light refreshments will be provided during health breaks; other meals will not be provided for participants. An evening session has been scheduled for May 1 (6:30 pm – 9:00 pm) to ensure that interested members of the public can attend outside of

regular working hours.

To assist with parties' preparation for the workshop, the NIRB has prepared a *draft* workshop agenda (Appendix A) to guide discussions around specific topics. By copy of this letter, the NIRB invites planned workshop participants to provide feedback on the draft agenda and ordering of discussion items on or before **March 14, 2019**.

To facilitate workshop discussions, the NIRB respectfully requests that Baffinland prepare a series of overview presentations to provide background on activities completed to date and planned activities for the upcoming 2019 shipping season. Each presentation would be followed by active discussion and questioning by workshop participants. Specifically, information should include an overview of shipping activities for the approved Project, including current status of ore production and transportation, as well as highlights of the 2018 shipping season and a summary of Baffinland's marine monitoring program. An update on the planned 2019 shipping season activities should also be provided. The NIRB invites Baffinland's feedback on or before **March 14, 2019** on the suggested grouping/separation and timing of discussion items set out in the draft workshop agenda (Appendix A).

The NIRB respectfully requests that workshop participants be prepared to provide community perspectives on project-related shipping, effectiveness of current monitoring and mitigation

measures, and results of ongoing community-based monitoring programs relevant to the marine environment. The NIRB further recommends that experts from Fisheries and Oceans Canada (DFO) and other government agencies with marine-related mandates or expertise plan to attend this workshop and be prepared to engage in discussions and provide informational materials or poster presentations to support engagement with the community.

NEXT STEPS

The NIRB requests that parties planning to attend the upcoming marine workshop provide our office with details regarding the number of representatives to be in attendance, their names, positions and respective area of expertise or authority. Due to the limited accommodations in Pond Inlet the NIRB encourages out-of-town participants to limit the number of planned representatives to allow space for as many groups to participate as possible. As noted above, the Board also invites feedback on the draft workshop agenda to be provided on or before **March 14, 2019**.
