Dear Mr. Barry,

As you are aware, technical meetings are being held next week as part of the Nunavut Impact Review Board's (the Board) reconsideration of Baffinland Iron Mines Corporation's (Baffinland or Proponent) *Phase 2 Development* project proposal, a proposed amendment to the approved Mary River Project. As the Government of Canada prepares for these meetings there is concern that information relevant to the *Phase 2 Development* review has not yet been submitted by Baffinland, namely the ice breaking assessment, simulation modelling report, and updated Cumulative Effects Assessment. Baffinland indicates in their technical submission dated March 26, 2019, that the planned submission date for these reports is anticipated between April and July 2019. In addition, submission of the updated management and monitoring plans are outstanding. Not having this information prior to the technical meetings, will limit the ability of the federal departments to discuss these topics in a meaningful and constructive manner at the technical meetings.

On behalf of the Government of Canada including Crown Indigenous and Northern Affairs, Fisheries and Oceans, Environment and Climate Change, Natural Resources, Health, Parks, and Transport Canada, I would like to express concern regarding the process for technical review of these additional documents in the *Phase 2 Development* review. Currently, Baffinland is proposing that the Terrestrial or Marine Working Group Meetings be used to manage the additional information; however these groups function in an advisory capacity only to Baffinland. There is no mechanism to facilitate public participation nor is it clear how information from, or decisions made at, these meetings would be integrated into the reconsideration process before NIRB.



The Government of Canada supports the Government of Nunavut (technical review comment, number 22.2), World Wildlife Fund (technical review comment, page 4), and the Qikiqtani Inuit Association (technical review comment, number 46) that this outstanding information should be subject to a thorough technical review, including a technical comment period and technical meeting with the Proponent, the Board and intervenors.

We appreciate the Board's consideration on this matter and look forward to participating in further stages of the *Phase 2 Development* Project Proposal reconsideration.
