Under separate cover to the Nunavut Water Board (NWB) an updated Application for Amendment No. 2 of Type A Water License 2AM-MRY1325 will be submitted by the end of the week. This submission is intended to satisfy the additional information requested by parties during the completeness check, including the following updated management plans:

- Emergency Response Plan
- Fresh Water Supply, Sewage and Wastewater Management Plan
- Surface Water and Aquatic Ecosystems Management Plan
- Aquatic Effects Monitoring Plan
- Waste Management Plan

- Spill Contingency Plan
- Hazardous Materials and Hazardous Waste Management Plan
- Borrow Pit and Quarry Management Plan
- Environmental Protection Plan

The updated Application for Amendment No. 2 of Type A Water License 2AM-MRY1325 as well as all the above listed management plans will also be submitted to the NIRB as some of the documentation is relevant to the impact assessment review.

In addition to the documents Baffinland is submitting to the NIRB and NWB, there were several requests to directly supply Interveners with specific information during the technical meeting. Baffinland has since supplied this information and would like to identify this for the record as these items were captured in Baffinlands Commitment List:

- Shape files from the Mine Site to Steensby Inlet were emailed to QIA on April 17, 2019
- The Freshwater Monitoring Program Fact Sheet, 2018 Aquatic Effects Monitoring Program Report, and 2018 QIA/NWB Annual Report were emailed to Frank Tester and representatives from the MHTO and Hamlet of Pond Inlet on April 30, 2019
