
Inuktitut Nunavut Water Board – QIA Technical Comments

#4 Inuktitut Incorporation of IQ in proposed North Railway

• Inuktitut



 QIA is seeking specifics of how Inuit engagement and consideration of Inuit Qaujimanituqangit (IQ) informed the proposed development and monitoring of the North Railway

Status

 Unclear how IQ has/will be incorporated into development plans for the North Railway



#5 Inuktitut Fish and Physical Effects of Flow Diversion

• Inuktitut



- QIA is not satisfied with the integration of adaptive management as it relates to flow diversion
- QIA further believes this information should be incorporated in a management plan

Status

 QIA requests updated management plan(s) to address flow diversion concerns



#8 Inuktitut Management and Monitoring Plans

Inuktitut



- Baffinland should update the SWAEMP to elaborate on monitoring activities (see Section 10)
- Baffinland should detail how this informs/prioritizes maintenance activities

Status

 QIA requests additional detail regarding frequency of monitoring, triggers for action and consideration of a broader suite of parameters



#9 Inuktitut Management and Monitoring Plans

- Summary
 - Baffinland should resubmit plans that do not delay details/recommended actions until post-approval
- Status
 - QIA requests revised management plans be submitted for consideration



#10 Inuktitut Management and Monitoring Plans

• Inuktitut



 QIA is seeking additional information on how calcium chloride is monitored to manage runoff into local watercourses

Status

 QIA is looking to better understand Baffinland's dust suppressant activities and corresponding monitoring



#11 Inuktitut Management and Monitoring Plans

• Inuktitut



- QIA believes the amended Water Licence should require Baffinland to monitor the construction, operations and closure of the North Railway
- QIA requests the geotechnical monitoring program be submitted prior to construction approval

Status

- Baffinland does not agree that the Water Licence should require monitoring of the North Railway
- QIA is awaiting the submission of a geotechnical monitoring program



#12 Inuktitut Management and Monitoring Plans

• Inuktitut



 Baffinland should share records of inspections, triggers, and corrective actions with reviewers as a reporting requirement of the amended Water Licence

Status

- QIA disagrees with Baffinland's assessment that these concerns are addressed in the existing licence
- QIA is awaiting the submission of a geotechnical monitoring program



#14 Inuktitut Management and Monitoring Plans

- Summary
 - QIA is concerned that the Tote Road has still not been constructed as designed by Hatch (2014)
 - Baffinland has confirmed they will not commit to
- Status
 - QIA's concerns regarding the Tote Road remain outstanding



#16 Inuktitut Adaptive Management

Inuktitut



 QIA is concerned with the lack of detail in current management plans regarding what monitoring thresholds trigger mitigative action for all relevant water quality parameters

Status

- Baffinland's response framework only responds to exceedances of TSS and turbidity
- QIA is concerned by the lack of mitigative measures for remaining water quality parameters



#17 Inuktitut Fish and Physical Effects of Flow Diversion

• Inuktitut

- Summary
 - QIA is concerned that Baffinland has not conducted and/or shared sitespecific fish passage assessments along the proposed North Railway
 - There is limited evidence to suggest the North Railway is designed to minimize impacts to fish
- Status
 - This concern remains outstanding



#18 Inuktitut Fish and Culvert Passage

Inuktitut



- QIA is concerned that Baffinland will not complete the Fish Passage Monitoring Program during the Water Licence process
- This information has implications for the design and construction of the North Railway
- QIA is also concerned by the less rigorous approach to monitoring along the North Railway in comparison to the Mine Site

Status



#20 Inuktitut Construction – Initial Conditions

- Summary
 - QIA requests that permafrost conditions be assessed prior to any construction approvals for the North Railway deviation at Kanajjuq
- Status
 - This concern remains outstanding



#22 Inuktitut Construction – Settlement

• Inuktitut



 QIA is concerned by Baffinland's proposed usage of satellite imagery (once per year), to identify areas showing increased settlement

Status

- QIA is seeking additional evidence to prove the viability of this technique for the North Railway
- If adopted, QIA recommends findings be reported publicly to the NWB on an annual basis



#23 Inuktitut Adaptive Management - SWAEMP

• Inuktitut



- QIA is concerned by the lack of monitoring for medium/high risk diversions and fish-bearing streams in proposed management plans
- It is unclear to what extent the proposed monitoring program will be included in management plans

#24 Inuktitut Construction – Stream Crossings

- Summary
 - QIA recommends the NWB develop a new section of the Water Licence devoted to:
 - Stream crossings,
 - North Railway construction
 - Relevant reporting requirements
- Status
 - These concerns remains outstanding



#25 Inuktitut Construction – Engineered Mitigation and Design

• Inuktitut

Summary

- QIA is seeking a timeline for completion of modelling, testing, final design and final approval of the North Railway
- QIA recommends bi-weekly reporting during construction on deviations from approved construction drawings
- QIA requests that the North Railway Longterm Monitoring and Maintenance Plan be considered during the Water Licence amendment process

Status

- These concerns remains outstanding
- The requested timeline may require adjustment based upon the final rail alignment around Kanajjuq



#26 Inuktitut Engagement with Inuit Communities

• Inuktitut



- QIA has serious concerns with the adequacy of engagement with Inuit relating to discussions around water use, water quality and water flow
- QIA has requested additional detail on meetings where the proposed amendment to the Water Licence was/will be a central topic

#27 Inuktitut Inadequate IQ Baseline Data Collection

• Inuktitut



- QIA believes Baffinland has underestimated Inuit values and use due to inadequate collection and consideration of IQ
- Consequently, there is limited information available to support the assessment of effects on Inuit use and values for water

Status



#28 Inuktitut Inadequate Assessment of Impacts to Inuit Water Rights

• Inuktitut



 QIA is concerned by Baffinland's limited consideration of Section 20.3.3 of the Nunavut Agreement when determining if the proposed project will substantially affect the quality, quantity or flow of waters flowing through IOL

Status



#29 Inuktitut IQ and Snow Management

- Summary
 - QIA is seeking to better understand how IQ was considered and integrated into the updated Snow Management Plan (May, 2019)
- Status
 - This concern remains outstanding



#30 Inuktitut IQ and Monitoring

- Summary
 - QIA is concerned by the limited consideration of IQ in the Environmental Protection Program and Aquatic Effects Monitoring Plan
- Status
 - These concerns remains outstanding
