ک^اےدا Igloolik QIA recognizes and understands the importance of providing the NWB with clarity on the status of a WCA prior to Final Hearings, presently scheduled to take place in Pond Inlet on April 23rd-25th, 2013.

QIA and the project proponent continue in discussions with a clear desire to reach a WCA prior to Final Hearings. QIA commits to providing further, and hopefully positive confirmation, as to the status of a WCA on or before Friday April 19th, 2013.

As per our direct discussions today, QIA understands that in the event parties are not able to reach a WCA, and if either party requests the involvement of the NWB in order to resolve the absence of a WCA, as per Article 20.3.2 of the NLCA, that this may result in alternative scheduling of the Final Hearing. If such a circumstance were to occur QIA can assure the NWB, and all other participants to the Final Hearing process, that such a request would only occur if QIA feels that it has otherwise exhausted the possibility of reaching a WCA directly with the proponent in advance of Final Hearings.
