Re: <u>Licence No. 2AM-MRY1325, Type "A" Water Licence – Next Steps and Draft</u>

Agendas for the Mary River Project, Amendment No.1 Application

As a follow-up to the February 25, 2015 Pre-Hearing Conference Decision Report¹ (PHC Report), issued by the Nunavut Water Board (NWB or Board) for an Amendment (No.1) application filed by Baffinland Iron Mines Corporation (BIMC or the Applicant) for the licence issued to the Mary River Project, Licence No. 2AM-MRY1325, the NWB takes this opportunity to further confirm that the Public Hearing (Hearing) for the application will be held, as scheduled, in the community of **Pond Inlet**, Nunavut, on **May 6 – 7, 2015**.

Consistent with relevant timelines included in the PHC Decision, the NWB has received additional submissions² pertaining to the amendment application from the Applicant as well as final written submissions³ from the following intervening parties: Aboriginal Affairs and Northern Development Canada (AANDC), Environment Canada (EC), the Qikiqani Inuit Association (QIA), and the Hamlet of Pond Inlet

Based on remaining timelines included in the PHC decision, the NWB anticipates receipt of the Applicant's response(s) to interveners' final written submissions on or before **April 29, 2015** and copies of the presentations for the public hearing and community session (in English with Inuktitut summary) from parties intending to make representation to the Board during the Hearing on or before **May 1, 2015.** Once the NWB receives the pending or anticipated documents, it will distribute them for public review and information.

As part of the preparations for the Public Hearing, the NWB has included, as attachments to this correspondence, copies of the draft agendas. Prospective participants are invited to provide any comments with respect to the agendas to the NWB's Manager of Licensing at licensing@nwboen.ca by 3:00 p.m., MST, Friday, May 1, 2015. In addition, intervening parties are asked to include in their responses concerning the agendas, confirmation of their participation as well as provide the names of their representatives to ensure that adequate preparations are made for attendees. The NWB will distribute publicly copies of the final versions of the agendas and the presentations in advance of the Public Hearing.

The NWB recommends that prospective participants review their submissions and the relevant documents associated with the application with the aim of identifying, during the Hearing, the issues or items in their submissions that have been resolved, or remain outstanding and/or ongoing. The Applicant and each intervening party will be allotted approximately 90 minutes and 60 minutes, respectively, for their presentations. To provide community members with access to the information presented, intervening parties should make available for distribution during the Public Hearing, paper copies of their presentations in English and Inuktitut (25 copies in English and 25 copies in Inuktitut for the main and community session presentations). The NWB has arranged for simultaneous English-to-Inuktitut and Inuktitut-to-English interpretation to ensure that all interested persons are able to fully participate in the hearing.
