Hi Karen, Assol

As I'm sure you've already heard, Baffinland will begin de-mobilizing employees from the Mary River site today due to a COVID outbreak. Operations will be temporarily suspended at the same time. Industrial cleaners will be brought to site to provide enhanced sanitization services in preparation for the return to full operations and we will continue to work closely with Nunavut Public Health.

I can confirm that essential workers will continue to maintain all site infrastructure and execute environmental monitoring as required under our licenses and permits. We do not allow contact between Nunavut communities and the workforce and the risk to communities from this outbreak remains low. If completion of any requirements under the licenses become compromised because of this suspension we will be in touch to discuss, however, this is not anticipated at this time.
