Hello Assol,

With the Annual Security Review around the corner, could you please advise which version of Baffinland's Interim Closure and Reclamation Plan (ICRP) for the Mary River Project is the most recently approved version? Version 5 (October 2018) was approved in March 2018 on the condition that revisions be made by May 1, 2019. Correspondence in this regard is attached for your reference.

Baffinland has submitted revisions to the approved ICRP Version 5 in May 2019 as part of the Updated Application for Amendment No. 2 of Type A Water Licence 2AM-MRY1325. It is unclear to me whether the May 2019 version of the ICRP has been approved, or if we should be working with revision 5 of the ICRP in our assessment of the security associated with the project for the upcoming year.
