Dear Parties,

As a follow-up to the Nunavut Water Board's (NWB or Board) November 6, 2014 correspondence regarding the Annual Security Review (ASR) for the Mary River Project, the NWB wishes to advise that while some of its remote staff have received copies of all documents associated with the Mary River Project 2015 ASR, the Licensing Department in Gjoa Haven is yet to receive the complete set of documents that has been couriered by the Proponent. Therefore it should be noted the licensing department is in receipt of the documents that were sent to the Board through emails, which is not the full set of documents associated with the 2015 ASR.

The NWB in its November 6, 2014 correspondence anticipated that the Licensing Department in Gjoa Haven would have received the full set of documents for the 2015 ASR by November 6, 2014, and so the Board set the timelines in the ASR Process based on this anticipated date of receipt.

Currently, the NWB understands that some interested parties, including Aboriginal Affairs and Northern Development Canada (AANDC) and the Qikiqtani Inuit Association (QIA) have received, from the proponent, the complete set of documents associated with the 2015 ASR; therefore, in the interest of preserving the timelines set out in the NWB's November 6, 2014 correspondence, the Board asks that all interested parties, commence their technical review of the documents to the extent possible. Once the Licensing department receives the full set of documents for 2015 ASR, it will issue follow-up correspondence on this matter to indicate receipt.
