Hi Everyone,

Baffinland has reviewed the proposed 2016-17 ASR Process timelines provided for consideration by QIA and INAC in response to the NWB's letter Type "A" Water Licence No. 2AM-MRY1325 – Amendment No.1, Mary River Project; 2016 – 2017 Annual Security Review Process and Guidance for Timing with Respect to the Annual Security Review Required Under Part C and Schedule C sent on October 5th, 2016. In general, Baffinland is willing to work with the parties under either timeline to put in place the financial security by February 2017 as proposed.

Based on this review and internal constraints, Baffinland would like to notify ASR participants that the 2017 Work Plan and associated financial security estimate will be delivered to the NWB, QIA, INAC and other parties by November 4, 2016. Baffinland apologizes for this delay however, due to internal budgeting and financial approval process, and the forward looking nature of the annual work plan process, it was felt that delivering a slightly delayed but firm and accurate submission was preferable to a submission that was subject to change based on the results of the financial approval process. Hopefully this change is acceptable to the parties.
