The Nunavut Water Board ("NWB") acknowledges receipt, on November 6, 2017, from Baffinland Iron Mines Corp. Consistent with the review period allowed for similar submissions in the past, interested persons/parties are allowed thirty (30) days to review the submission and make representations to the NWB in the context of the 2017 – 2018 Annual Security Review (ASR) Process. All representations shall be submitted to the NWB by mail, fax, or email no later than December 8, 2017, 5:00 p.m., Mountain Time. Following the receipt of interveners' submissions pertaining to the BIMC's 2018 Work Plan, the NWB will review the submissions and contact the respective parties should concerns arise or additional information be required.

In addition to BIMC's submission, the Qikiqtani Inuit Association (QIA) and Indigenous and Northern Affairs Canada (INAC) have both provided submissions related to aspects of the 2017 – 2018 Annual Security Review (ASR) process that should be appropriately considered during the ASR process.
