Dear Parties,

On December 4, 2023, the Nunavut Water Board (NWB or the Board) distributed a correspondence providing guidance for the Annual Security Review associated with the 2024 Work Plan (the ASR), as required under Licence No: 2AM-MRY1325 (the Licence), issued to Baffinland Iron Mines Corporation (Baffinland or the Licensee) for the Mary River Project (the Project). The Board requested that the Licensee, Crown-Indigenous Relations and Northern Affairs (CIRNA), and the Qikiqtani Inuit Association (QIA) provide comments with respect to the ASR process and proposed timelines.

On December 7, 2023, the QIA requested that the January 25, 2024, date for filing written submissions regarding the Licensee's 2024 Work Plan and any updates to the reclamation security estimates for the Project be moved to January 31, 2024.

On December 11, 2023, CIRNA advised the Board that they do not have concerns of the proposed timeline associated with the annual security review 2024 work plan for Mary River Project Licence No. 2AM-MRY1325.

The Board would like to inform Parties that the Board adjusted the timeline for the 2024 ASR as requested by QIA. Table 1 with updated timeline is attached to this correspondence.
