In accordance with Part E, Items 5 & 9 of our Licence 2AM-MRY1325, and based on recent discussions during your Inspection, we are notifying you of our intention to withdraw water from a discharge pond at coordinates; 17 W 503297 7975614.

Water from this location will be utilized for construction purposes (boilers/dust suppression) and will be taken such that draw down of the pond does not affect the surrounding drainage ditches.

Water will be taken from this location will be limited to the allowable amounts as specified in Part C; Item 1 of our Licence 8BC-MRY1416 until freeze up, when the water source for this purpose will revert to Km32.

Daily volumes taken will be documented and provided monthly.
