As per the 170509 Inspector's Direction 2AM-MRY1325- Item 3: To amend their Waste Rock Management Plan with a plan for treating non-compliant water, including contingencies, and submit this plan to the Nunavut Water Board for approval. This amendment to their plan is to be submitted to the Nunavut Water Board and an inspector by October 31, 2017.

Baffinland is currently in the process of revising the Phase 1 Waste Rock Management Plan to include treatment of non-compliant water at the Waste Rock Sedimentation Pond in consultation with expert consultant help. Baffinland would like to request an extension of two weeks to November 15th for the submission of the amended Phase 1 Waste Rock Management Plan to address treatment of non compliant water at the facility.
