Thank you for providing the notification for construction. Please note that the target start date of August, 18 is within the 60-day period allotted by the Board for review of the notification and accompanying materials by the Board and interveners. Therefore, this target date may not be feasible.

While BIMC's operational requirements are very much understandable, and a Board approval is not required in the case of a notification of construction, a proper review process must occur within a reasonable time period (60 days, as required by Part D, Item 2 of the Licence).
