RE: Notification of Planned Construction Work

Mary River Mine Haul Road and Cross Cut

Mary River Project - Type 'A' Water Licence - 2AM-MRY1325 - Amend. No. 1

Baffinland Iron Mines Corporation (Baffinland) is pleased to submit final design and for-construction drawings for planned construction work at the Mary River Project (the Project) in accordance with Part D, Item 2 of Type A Water Licence 2AM-MRY1325 - Amendment No. 1 (Type A Water Licence). The planned construction work includes the upgraded Mine Haul Road and Cross Cut to be constructed at the Mary River Mine Site as described in Water Licence Modification No. 7 and approved under Motion No. 2018-A1-010.

This letter provides notice to the Nunavut Water Board (NWB) that Baffinland intends to begin construction work following 60 days of this submission (11 April 2019). Construction will proceed until the completion date, anticipated to be July 2019 for the Cross Cut (Hillside Road) and December 2019 for the entirety of the Mine Haul Road. It is noted that reclamation securities are in place for this activity under the 2018 Work Plan Addendum, and were posted with the Qikiqtani Inuit Association (QIA) on 27 July 2018.


