



In 2017 Baffinland submitted the design for the expansion of the Crusher Pad (Modification No. 1) and the associated Sedimentation Pond (Modification No. 5), which were both approved by NWB. In executing the design outlined in the Golder Associates April 17, 2017 Technical Memorandum on the Crusher Pad expansion, Baffinland consulted Golder to implement a field change to the width of the single land of traffic between the stockpile and the perimeter ditching from 8

metres in width to 3 metres in width. Golder approved this design, and provided the attached field directive signed by a Professional Engineer registered in NT/NU.

Baffinland maintains that while this is a change to the design submitted and approved in Modification Request No. 1, the change was documented by the Engineer. Per Schedule D, Item 1 (d), this field decision will be documented in the Construction Summary Report (CSR) currently under development for the Crusher Pad facility and Sedimentation Pond.

Please advise if a modification request is required, or if the attached field directive and inclusion of this change in the CSR is adequate.
