Hello Assol,

We have reviewed the inquiry on Modification 10 to the Mary River Water Licence, and have considered it in relation to the scope of the previously approved project. It is our understanding from the application that, as much as the footprint of the landfill and landfarm are being updated for accuracy in the water licence, both of these structures remain within the overall larger area assessed by the NIRB as reflected in the FEIS for the Mary River Project. The NIRB would note that regardless of their final proximity or relationship to each other (i.e. one within the other) such updating of project components within the larger area assessed would not be a change scope, and therefore not constitute a modification to the NIRB's Project Certificate. Updates to structures necessary for engineering or practical implementation purposes are expected between the impact assess and permitting phase and the NIRB would capture these through its ongoing monitoring function, including submissions of updated site management plans to the NIRB, but would like to reduce the number of modifications received when they are actually updates to project design. Do not hesitate to contact me should you have any questions regarding this modification or the general monitoring of the Mary River Project.
