## Dear Assol Kubeisinova:

This letter presents the Qikiqtani Inuit Association's (QIA) response to the Nunavut Water Board's (NWB) request<sup>1</sup> for interested parties to provide comments regarding Baffinland Iron Mines Corporation's (Baffinland) Modification Request No.10, Upgrades at the Mary River Mine Site, submitted by Baffinland on September 5, 2018.<sup>2</sup> The NWB requested that comments be submitted by September 20, 2018, 5:00 p.m., Mountain Standard Time.

As the Designated Inuit Organization for the Qikiqtani region, QIA and Baffinland signed the Commercial Lease No. Q13C301<sup>3</sup> (the Lease) for the Mary River mine in 2013. QIA's requests as presented in **Table 1** herein are focused on items as they relate to the Lease.

Without limitation, QIA considers the following elements of the modification request to have a relationship to the Lease and/or associated Water Compensation Agreement:

- Adequate reclamation security;
- Whether the proposed activities satisfy all other applicable environmental laws and regulations as well as the Lease;
- Updated Environmental Management Plans associated with water quality, quantity; and flow
- For-construction and as-built documentation.

Included in the modification request submitted by Baffinland are the following:

- A self-assessment of the proposed changes versus the scope of the Approved Project, as described in the Final Environmental Impact Statement (FEIS) and the FEIS Addendum; and
- 2. The **modification request** as per the submission requirements of the Water Licence.

トーβーΔ<sup>®</sup> Sanikiluaq In an email to the NWB on September 12, 2018<sup>4</sup>, the Nunavut Impact Review Board (NIRB) states that the proposed activities; remain within the overall larger Project Development Area assessed by the NIRB and reflected in the FEIS for the Mary River Project. Consequently, the changes proposed by Baffinland would not constitute a change in scope of the project or a modification to the NIRB's Project Certificate. QIA agrees with the NIRB's determination that a reconsideration of the Project Certificate for this proposed modification is not necessary.

Notwithstanding the above, QIA is available to discuss this letter and the Lease obligations with the NWB at a time that is mutually agreeable.
