I would like to note in regards to Baffinland's response to QIA-1 that the Licence requires IFC submission 60 days ahead of construction (Part D, Item 2):

*The Licensee shall submit to the Board for review and acceptance, at least sixty (60) days prior to construction or in a timeframe otherwise approved by the Board in writing, final design and for-construction drawings, stamped and signed by a Professional Engineer, for all infrastructure and/or facilities designed to contain, withhold, divert or retain Water and/or Waste, as authorized under the Licence.*
