Section 1.4 of the request states, "Biophysical environment components will require minor updates to the current monitoring programs such as additional monitoring parameters and/or modifications to the locations of monitoring stations to account for an expanded project footprint." What are the proposed updates?
2. Please correct the text in sections 1.7.2 and 1.7.3 to indicate a minimum 31-m distance from waste and stockpiled materials to the high-water mark.
3. Please indicate any inspections / monitoring to be undertaken during the operation in section 2.4.
4. Could you please provide relevant schedules for construction?
