Hello Assol,

In reviewing the comments provided by Environment and Climate Change Canada (ECCC), Baffinland provides the following responses;

- 1. Baffinland notes that the concerns expressed by ECCC regarding the placement of waste rock at the Waste Rock Facility (WRF) are unrelated to the design of the WRF Pond, which is the subject of this modification request. Updates to the Waste Rock Management Plan are pending, indicated to be completed in December 2018. The recommendation as provided is noted.
- 2. Baffinland indicated in our 27 August 2018 response to comments that the liner will be inspected by a qualified engineer from Golder Associates, as well as the liner contractor Layfield who have expertise in installation and repair of lined structure.

Please let me know if you have any concerns regarding Modification No. 8, however Baffinland believes that all comments have been sufficiently addressed at this time and we are anticipating the NWB provide direction and anticipated date of approval.
