Thanks Justin. FYI for our PWSP discharge at Milne Port (MP-1a) we encountered some complications. Just prior to starting the discharge on Friday the pond turned over and ice adhering to the bottom floated up to the surface, stirring the lot up and increasing ammonia levels to unacceptable concentrations. We are in a holding pattern until it settles out and the pH increases (driving off the ammonia). We will let you know as the situation progresses and the water quality once again improves.

I have attached photos showing the discharge end of the 3 inch discharge hose from the pond. Note the erosion protection measures.
