EC advises "Due to overlapping demands our expert reviewers will be unable to complete the review of Baffinland's AEMP and A&R plan by the NWB's June 6 deadline. EC is therefore requesting an extension to the commenting period. Environment Canada notes that the NIRB has circulated Baffinland's 2014 Annual Monitoring Report for comment and that the AEMP and A&R plans were provided as supporting documents for the Annual Monitoring Report. In the interest of efficiency Environment Canada is proposing to submit one comment letter that combines our comments for both the NWB and NIRB processes. With that in mind EC is requesting that the NWB extend their commenting deadline to align with NIRB's June 26 deadline."
