REASONS FOR DECISION

Executive Summary

This decision is in relation to an application before the Nunavut Water Board (NWB or Board) filed by Baffinland Iron Mines Corporation (Baffinland, Licensee or Applicant) for renewal of the existing type A Water Licence No: 2AM-MRY1325 (the Water Licence) for the Mary River Project (Renewal Application). The Renewal Application was filed by Baffinland on June 26, 2024, and seeks authorization to continue the use of water and deposit of waste associated with a Mining Undertaking¹ at the existing Mary River iron mine for a term of 15 years (until 2040).

The Mary River Project (Project) is located on Baffin Island and the mine is located approximately 160 kilometres (km) south of the Hamlet of Pond Inlet and approximately 1000 kilometres north of the City of Iqaluit, in the Qikiqtani Region of Nunavut. Between 2008-2012, the Mary River Project was assessed by the Nunavut Impact Review Board (NIRB) and was approved to proceed by the responsible Ministers in 2012 when the NIRB issued Project Certificate No. 005 to govern the Project. In June 2013, the Nunavut Water Board issued, and the Minister of Aboriginal Affairs and Northern Development Canada (as the Minister was called then, now Minister of Northern Affairs) approved the issuance of type A Water Licence No: 2AM-MRY1325 to govern the water use and waste deposit associated with the Mary River Project. The Project as currently approved involves the construction, operation, closure and reclamation of an open-pit mine for the purposes of extracting, transporting and shipping high-grade iron ore from the ore deposit known as "Deposit No. 1" to markets abroad via land transportation to the north along an approximately 100-km long Tote Road linked to port facilities at Milne Inlet, and to the south along a proposed 150-km railway linked to port facilities at Steensby Inlet. The southern transportation infrastructure (railway and port facilities at Steensby Inlet) was not constructed during the term of the Water Licence, (June 2013-June 2025), but was included in the scope of the Water Licence issued in 2013 and remain included within the scope of the Renewal Application.

The NWB conducted a review of the Renewal Application, including a completeness check, technical review, and a Technical Meeting and a Pre-Hearing Conference (TM/PHC). The TM/PHC and a Community Session was held in-person in Pond Inlet, Nunavut on December 3-4, 2024, facilitated by the NWB's staff, and with representatives of the Applicant and Interveners, the Qikiqtani Inuit Association (QIA), Crown-Indigenous Relations and

Northern Affairs (CIRNA), Environment and Climate Change Canada (ECCC), and Fisheries and Oceans Canada (DFO) in attendance. Due to the lack of accommodations available in Pond Inlet during these meetings, the NWB also hosted a community gathering in Iqaluit with NWB staff and representatives from the North Baffin communities including Arctic Bay, Clyde River, Sanirajak (Hall Beach), and Igloolik participating. The Pond Inlet and Iqaluit venues were connected through an on-line zoom connection so that the North Baffin communities were able to participate in the TM/PHC, including the Community Session in relation to the Renewal Application conducted during the evening of December 3, 2024, to discuss the Renewal Application with interested members of the public and the representatives from the North Baffin communities.

On December 19, 2024, the NWB released the Pre-Hearing Conference Decision Report for the Renewal Application and provided notice that the NWB would conduct an in-person Public Hearing in the community most affected, Pond Inlet, sometime during the week of March 10-14, 2025. Although the Public Hearing was conducted in-person, and Community Representatives from Arctic Bay, Clyde River, Sanirajak (Hall Beach), and Igloolik were flown into Pond Inlet for the Public Hearing, recognizing limits on travel and accommodation and for the convenience of parties and the public, the Board also provided an audio/video link to the proceedings. On March 11 and 12, 2025, the Board held the Public Hearing in respect of the Renewal Application as planned. A Community Session was hosted by the NWB on the evening of March 11, 2025, where the community representatives from Arctic Bay, Clyde River, Sanirajak, and Igloolik and interested members of the community of Pond Inlet were invited to ask questions, share their knowledge and provide the Board with their comments in relation to the Renewal Application. The Board closed the Public Hearing Record for the Renewal Application at the conclusion of the Public Hearing on March 12, 2025, and remitted the file to the NWB's duly-appointed three-person decisionmaking Panel for the file (Mary River Panel or P4) for decision-making.

To assess whether to approve the Renewal Application submitted by Baffinland, the Board considered:

- The information provided by Baffinland in support of the Renewal Application;
- Technical review comments in respect of the Renewal Application provided by the Board, Interveners and the public;
- The Applicant's commitments and responses to information requests from the Interveners during the technical review of the Renewal Application;
- The final written submissions filed with the Board in advance of and during the Public Hearing, and
- The information provided during the Public Hearing and Community Session.



On this basis, the three-member panel of the Board, Mary River Panel (P4), duly appointed by the Board to consider the Renewal Application has, by way of **Motion # 2025-01-P4-06** decided the following:

- To grant Baffinland's request for the renewal of type A Water Licence No: 2AM-MRY1325 (Water Licence) for a term of 15 years, as set out in the attached Renewed Water Licence No: 2AM-MRY2540 (Renewed Water Licence or Licence);
- Specific terms and conditions of note in the Renewed Water Licence include the following:
 - o The scope of the Licence as set out in Part A remains unchanged;
 - Revision to the existing term and condition in Part B, Item 17 and addition of two Items to Schedule B (Items 26 and 44) to address QIA's request to require the Licensee to ensure that the results of Inuit Qaujimajatuqangit and Inuit Qaujimaningit (collectively IQ) studies and Inuit-led and community-led monitoring are incorporated into the Water Licence in general, and specifically the results of such studies and monitoring be considered and incorporated into relevant management plans required under the Water Licence;
 - Although there were no changes required to Part C and Schedule C (the security provisions) of the Water Licence were required, during the Board's consideration of the Renewal Application, Baffinland, the Qikiqtani Inuit Association and Crown-Indigenous Relations and Northern Affairs indicated that the parties were working to conclude a Security Management Agreement (SMA) that would govern how reclamation security held under the land lease and the Water Licence would be allocated and accesses by the parties—as the SMA negotiations had not concluded by the close of the Public Hearing Record, the NWB did not consider the SMA in fixing security to be held under the Renewed Water Licence, which remains to be dealt with as set out in the existing process established under Part C and Schedule C of the Licence;
 - Other Parts and Schedules of the Licence have been amended to align the requirements of Renewed Water Licence with other NWB Licences and new Regulations and to include requirements for the Applicant to provide additional information.



SECTION I: FILE BACKGROUND AND REGULATORY HISTORY

Current Application

The Application before the Board was filed by Baffinland on June 26, 2024 and proposes to renew the existing type A Water Licence No: 2AM-MRY1325 for a term of 15 years to continue their existing operations associated with the construction/operation/closure of Mary River Project (Application or Renewal Application). The Renewal Application seeks the NWB's authorization to continue the use of water and deposit of waste associated with a Mining Undertaking² at the existing Mary River mine.

All documents filed in association with the Renewal Application, as well as all documents provided by the Applicant in support of the Renewal Application are listed in detail in **APPENDIX C: List of Submissions and Correspondence** of this Reasons for Decision. A list of documentation filed as Exhibits during the Public Hearing is provided in **APPENDIX B – Exhibit List**. Scope of the Renewal Application

In the Renewal Application, Baffinland is proposing no changes to the scope of the approved project activities under the existing Water Licence No: 2AM-MRY1325, which includes the following:

- The existing Licence allows for the use of water for domestic and industrial purposes at the Milne Port (Milne Inlet) Site, Mine (Mary River) Site, Steensby Port (Steensby Inlet) Site and the railway camps as follows:
 - o Water Use during Construction Phase 689,000 m³/year
 - o Water Use during Operations Phase 353,000 m³/year
 - Water use authorized for Dust Suppression up to 1,500 m³/day to a maximum of 547,500 m³/year
- Construction/operation of Tote Road (all weather road) to connect Mine Site to Milne Port Site:
- Construction/operation of railway to connect Mine Site to Steensby Port;
- Water management infrastructure including water course crossings, flood control infrastructure and other measures including diversions, alteration of flow or storage by means of dykes or dams, and related maintenance;
- Treatment facilities for sewage, wastewater and oily stormwater, contaminated snow and soil;
- Waste sorting, management, and disposal facilities including landfills and incinerator systems;
- Management of waste rock stockpile, ore stockpile, and related runoff management;
- Storage and management of fuel and other hazardous material;
- Ongoing decommissioning of existing and historic camp infrastructure; and

• Other activities in support of engineering and scientific studies for the Project and ongoing maintenance to existing project infrastructure.

Licensing History

Reflecting the NWB's jurisdiction for licensing undertakings requiring the use of water and deposit of waste as established under Article 13 of the Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement) and the Nunavut Waters and Nunavut Surface Rights Tribunal Act, S.C. 2002, c. 10 (NWNSRTA or Act), the NWB has previously issued one (1) Licence and one (1) Amendment for this undertaking to date:

- 1. Licence No: 2AM-MRY1325
 - o Approved on July 15, 2013;
 - Allowed for the use of 580,000 cubic metres of water annually during construction phase, 230,000 cubic metres of water annually during the operation phase, and the deposit of waste in support of a Mining Undertaking.
 - i. Amendment No 1: 2AM-MRY1325
 - o Approved on September 2, 2015;
 - Reflected the significant modification to the Mary River Project as described in the Early Revenue Phase project proposal as assessed by the Nunavut Impact Review Board as a reconsideration of NIRB Project Certificate No. 005, and approved to proceed to licensing in 2014;
 - O Allowed for the use of 689,000 cubic metres of water annually during construction phase, 547,500 cubic metres of water annually during early revenue phase, 353,000 cubic metres of water annually during the operation phase, and the deposit of waste in support of a Mining Undertaking.

Regulatory and Procedural History of the Renewal Application

Pre-Licensing Regulatory History of the Renewal Application

The Nunavut Planning Commission (NPC)

On May 24, 2024, the Nunavut Planning Commission (NPC)³ noted that activities associated with this proposal were previously reviewed by NPC, and conformity determinations were issued on April 30, 2008, August 12, 2011, February 8, 2016, January 26, 2017, May 18, 2018, December 16, 2019, June 7, 2022, and February 2, 2023, which still apply. The NPC further noted that the activities were previously screened and reviewed by the Nunavut Impact Review Board (NIRB) under Project Certificate No. 005, and that the "project proposal is exempt from screening by the NIRB because the NPC is of the understanding that

it does not change the general scope of the original or previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the Nunavut Agreement do not apply".

As a result, the NWB has concluded that the applicable pre-licensing conformity and impact assessment requirements for the Renewal Application under Articles 11 and 12 of the *Nunavut Agreement*, Part 3 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*) and ss. 38 and 39 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, S.C. 2002, c. 10 (*NWNSRTA*) have been met, and the Renewal Application can be processed by the NWB.

Key Steps in the NWB's Procedural History for the Renewal Application

The following section includes a brief overview of the procedural history for the Renewal Application. It should be noted that the following listing captures only the major procedural steps associated with the Renewal Application.

The following listing summarizes only selected key steps in the procedural history of the NWB's processing of the Renewal Application. Inlet and Iqaluit venues were connected through Zoom connection.

December 19, 2024 NWB issued the Pre-Hearing Conference Decision for the file;

including a list of commitments, identifying issues to be addressed at the Public Hearing, and tentative timelines as the Application

proceeded to Public Hearing.

<u>December 27, 2024</u> NWB published the Notice of Public Hearing to be held in Pond Inlet

in the week of March 10, 2025.

<u>February 11, 2025</u> Interveners filed final written submissions.

February 21, 2025 Baffinland provided responses to final written submissions.



February 27, 2025 All parties, except for QIA, filed their Public Hearing presentations

with the Board.

February 28, 2025 QIA filed an updated final written submission and was granted an

extension to file their Public Hearing presentation.

March 5, 2025 QIA filed their Public Hearing presentation.

March 11-12, 2025 NWB conducted the Public Hearing, and a Community Session on the

evening of March 11, 2025, in Pond Inlet.

NWB Timeline for Processing the Renewal Application

As set out under the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, S.C. 2002, c. 10 (*NWNSRTA* or *Act*), s. 55.2, the NWB is required to process a Renewal Application for a type A Water Licence within 9 months from the receipt of a complete application. The Board provided notice of a <u>complete</u> application on September 23, 2024. In calculating the Board's processing timeline, as expressly noted in s. 55.4 of the *NWNSRTA*, time that elapses while the NWB is awaiting receipt of information requested from the Applicant is excluded. In this case, and as illustrated by the key procedural steps listed above and outlined in the detailed list of submissions included in <u>APPENDIX C: List of Submissions and Correspondence</u>, the Board awaited receipt of additional information from the Applicant in September 2024 and February 2025. Accordingly, the 9-month timeline was suspended while the Board awaited information submissions from the Applicant for approximately 3 weeks. Reflecting these circumstances, the NWB has rendered this Decision well within the 9-month timeline required under s. 55.2 of the *NWNSRTA*.

Short-term Renewal Application

On December 4, 2024 during the Technical Meeting and Pre-hearing Conference (TM/PHC) associated with the Renewal Application, when discussing next steps and tentative timelines

for the Renewal Application to advance to the Public Hearing stage, parties were advised by the Board that in order to preserve the Board's and the Minister of Northern Affairs' (Minister) full timelines for decision-making after the Public Hearing, it is advisable for the Applicant to bring an application for a short term renewal of up to 180 days of the Water Licence under s. 9(1)(b) of the Nunavut Waters Regulations, SOR/2013-693 (Regulations) to bridge any potential gap between the expiry of Licence No: 2AM-MRY1325 on June 10, 2025 and the NWB's and Minister's completion of decision-making for the Renewal Application (and if recommended by the NWB and approved by the Minister, the issuance of a renewed licence)⁵. As permitted under s. 9(1)(b) of the Nunavut Waters Regulations, SOR/2013-69⁶ (Regulations), the STR Application can be processed by the Board without a Public Hearing. However, recognizing that under s. 55 of the Nunavut Waters and Nunavut Surface Rights Tribunal Act (NWNSRTA), the Board is required to provide at least 30 days' notice of an application before acting on the application, the Board recommended that Baffinland consider submitting a STR Application early in 2025.

On February 28, 2025 the Board received the STR Application from the Applicant. The STR Application requested the renewal of the Existing Licence on the following basis:

- Absolutely no changes to the Existing Licence (administrative or otherwise);
- The Short-term Renewal would not exceed 180 days from the date on which the Existing Licence expires (June 10, 2025) with the expiry of the STR occurring on the earlier of December 5, 2025 or on the grant of a Renewed Water Licence if the Board and Minister grant the Renewal Application and issue a Renewed Water Licence before December 5, 2025;
- No plans, studies, reports, or designs would be submitted in support of the STR Application as this information has already been provided during the Board's processing of the full Renewal Application; and
- Noting the assumption that even if the STR is granted, the Renewal Application will continue to be processed by the Board as timely and efficient a manner as possible.

Following the close of the comment period associated with the STR Application, the Board has decided to grant the Applicant's request to renew / amend type A Water Licence N: 2AM-MRY1325 to extend the expiry to the earlier of December 5, 2025 or on the date on which a Renewed Water Licence is granted, if the Board and Minister choose to

grant/approve the full Renewal Application and issue a Renewed Water Licence by December 5, 2025. On April 23, 2025, the Board issued the STR Licence to Minister for Minister's consideration.

SECTION II: SUMMARY OF FINAL SUBMISSIONS OF THE PARTIES

Qikiqtani Inuit Association (QIA)

QIA is a Designated Inuit Organization under the *Nunavut Agreement* and is one of three Regional Inuit Associations affiliated with Nunavut Tunngavik Inc. (NTI). QIA works closely with partners as well as different levels of government, to represent Inuit in the Inuit Nunangat, the Inuit homeland. QIA's participation in the review of the Renewal Application is focused on ensuring that adequate protection of the environment occurs by requiring the Applicant to implement best practices in their mitigation and monitoring programs.

The QIA identified a number of key issues in their initial comment submissions on the completeness of the Renewal Application, in their full technical review comment submissions, and in their submissions at the Technical Meeting (TM). A list of those issues was provided in the PHC Decision issued by the NWB on December 19, 2024.

Based on the comments QIA provided to the Board and discussions during the Technical Meeting and Pre-Hearing Conference, a number of commitments were outlined in the List of Commitments provided within the Pre-Hearing Conference (PHC) Decision. In addition to that, as set out in detail in **APPENDIX C: List of Submissions and Correspondence**, on February 7, 2025, the QIA provided their final written submission to the NWB, summarizing QIA's comments on the Renewal Application. QIA also provided a supplementary submission with revised status of their technical comments on February 28, 2025. The QIA attended and made presentations during the technical and community sessions at the in-person Public Hearing for the Renewal Application in Pond Inlet on March 11 and 12, 2025, and engaged in further discussions on outstanding issues at that time.

In their final written submission, the QIA's discussion was focused on the following topics:

- Technical Comments provided before and during TM/PHC;
- Inuit Qaujimajatuqangit and Inuit Qaujimaningit;
- Cumulative Effects; and
- Draft Licence Framework.

Technical Comments

The QIA stated that most of their comments from the technical review stage have been considered resolved, based on their agreement with the Applicant on the necessity of the inclusion into the Water Licence of the following:

1. Commitment by Baffinland:

Baffinland will collaborate with QIA to incorporate the outcomes of QIA-led data collection into relevant management plans listed in Part B Item 14 of the Water Licence, and will plan to submit any consequential updates to the NWB with the submission of the 2026 Annual Report. The timing of this commitment is contingent on QIA providing Baffinland with available verified QIA program-led data relevant to Project water use and management and/or waste generation and management by the end of September, 2025.

2. Revision of Licence Part B, Item 17 in accordance with the following:

The Licensee shall annually review and where appropriate modify the Plans and Manuals referred to in this Licence as required by changes in operation, technology, and/or the findings of applicable studies, monitoring and assessments. The Plans and Manuals shall incorporate design changes, adaptive engineering required and implemented during construction, operation and closure, changes to monitoring strategies and changes to management strategies, on the basis of actual site conditions and study, monitoring and assessment results, including proponent led, community-led and QIA-led monitoring and studies, over the life of the Project. Revisions to the Plans or Manuals are to be submitted in the form of Addenda to be included with the Annual Report required by Part B, Item 4 [Part B, Item 2] complete with a revisions list detailing where significant content changes are made.

3. Revision of Licence Schedule B, Item 1 to read:

The Licensee shall file with the Board no later than the 31st of March of the year following the calendar year being reported, an Annual Report on the appurtenant undertaking which shall contain the following information: ...

e. Monitoring...

iv. a summary of results relevant to water use and management/waste disposal and management generated by QIA-led monitoring programs (such as the Inuit Stewardship Program) together with a summary of any agreed actions to be taken by the Proponent in response (including plan updates), where such monitoring results are provided in final to the Proponent by QIA at least 5 months prior to the Annual Report deadline...

g. Plans/Reports/Studies...

xiv. a summary of results relevant to water use and management/waste disposal and management generated by QIA-led studies (such as those generated as part of the Inuit Stewardship Program) together with a summary of any agreed actions to be taken by the Proponent in response (including plan updates), where such studies are provided to the Proponent by QIA in final at least 5 months prior to the Annual Report deadline.

QIA provided the status of all technical comments and requested the Board that their recommendations for the unresolved comments become Water Licence conditions.

Inuit Qaujimajatuqangit and Inuit Qaujimaningit

QIA requested the Board to give full consideration to Inuit Qaujimajatuqangit and Inuit Qaujimaningit (collectively IQ) in its decision-making upon submission of the Pond Inlet Freshwater IQ Study. QIA emphasized that Inuit have experienced significant freshwater impacts that have exceeded predictions and are captured by Baffinland's monitoring system. QIA also highlighted that the Tusaqtavut studies ¹⁰ should be considered as evidence.

Cumulative Effects

QIA highlighted their concerns about cumulative effects and noted that these should be considered in the Water Licence. QIA also stated that the management, monitoring, and mitigation plans should account for cumulative effects. QIA further maintained that their recommendations on cumulative effects fall within the Board's authority under the *Nunavut Agreement*, and provided supporting arguments in the form of legal memorandum.

Draft Licence Framework

QIA provided their comments on the Draft Water Licence Framework as Appendix to their final written submission on February 7, 2025.

On February 28, 2025, the QIA submitted a correspondence to the NWB as a revision to their final written submission of February 7, 2025. The QIA highlighted that they had agreed to support the Renewal Licence based on Baffinland's commitment to include Inuit Qaujimajatuqangit and Inuit Qaujimaningit (collectively IQ) through the Inuit Stewardship Program (ISP), however, on February 21, 2025, Baffinland informed QIA it would not be providing funding for the ISP. As a result, QIA stated that as the resolution of the technical comments relating to IQ was directly dependent on integrating ISP studies' outcomes, QIA no longer has confidence that IQ and data from community-based studies will be properly integrated in the Project's activities. Therefore, fulfilling its role as a Designated Inuit Organization, QIA reverts the status of Technical Comments QIA-TR-24 and QIA-TR-27 to

37 to "unresolved". QIA also noted that in consideration of the above, QIA will be reevaluating its position on whether to support the renewal of this Licence¹¹.

During their presentation, the QIA stated that there are 16 resolved and 22 unresolved comments, some involving recommendations to the NWB. The focus of QIA's discussion with respect to the unresolved comments was on the following areas:

- Compliance with environmental assessment predictions,
- Adaptive management,
- Impacts on fish habitat,
- Monitoring including monitoring for baseline conditions,
- Management of impacts of water withdrawal,
- Inuit engagement,
- Incorporation of Inuit Qaujimajatuqangit and Inuit Qaujimaningit, and
- Consideration of cumulative effects.

Parties were given a chance to ask questions following QIA's presentation. Baffinland asked QIA to confirm that QIA, Baffinland, and CIRNA are all committed to working together to come to an agreed security management agreement that aligns with the security review process outlined in Part C of the Water Licence. QIA responded by confirming that they are looking to work with the parties to complete a security management agreement prior to the Minister issuing the Licence for the Project.

With regards to QIA's unresolved comments, Baffinland asked for confirmation from the QIA that for technical comments 1, 2, 6, 7, 11, and 17, Baffinland has provided draft wording for commitments to QIA that are currently under consideration, and development of understanding on commitment language for comments 14 and 16. QIA responded by noting that the discussions are currently ongoing and that an update will be provided to the Board.

During the final closing remarks at the PH, QIA stated that based on their recent working with Baffinland, nearly all of their comments are now resolved with the exception of technical comment 5 (QIA-TR-5). The following updates were provided with regards to the final status of their technical comments:

- Technical comment 1 is resolved by Baffinland's commitment 31;
- Technical comment 2 is resolved by Baffinland's commitments 32 and 33;
- Technical comment 6 is resolved by Baffinland's commitment 34;
- Technical comment 7 is resolved by Baffinland's commitment 35;
- Technical comment 9 is resolved as Baffinland's has provided QIA with the requested information;

- Technical comment 11 is resolved by Baffinland's commitment 36;
- Technical comment 14 is resolved by Baffinland's commitment 37. The same commitment resolves technical comment 15;
- Technical comment 16 is resolved by Baffinland's commitment 38; and
- Technical comment 17 is resolved by Baffinland's commitment 36.

In addition, QIA stated they are satisfied that the technical comments 24 and technical comments 27 to 37 will be resolved if certain amendments and commitments are included in the Licence and properly implemented by Baffinland. The final agreed upon commitments along with their respective timelines and form of submission are listed in Exhibit 13 – Commitments List from the Public Hearing, March 12, 2025.

The following commitments were agreed upon by Baffinland and QIA during the PH as a result of their discussions on unresolved comments/concerns:

Commitment 31 in response to concern and/or recommendation by QIA (QIA-TR-1): Baffinland commits to the development of a one-time memorandum including the following aquatic monitoring information:

- Temporal plots of water quality results from lake and stream CREMP monitoring areas that include results from the baseline (2006 to 2013), construction (2014), and operations (2015 to 2024) periods for specific parameters associated with the mine site ore bodies or with blasting (i.e., aluminum, arsenic, cadmium, chromium, copper, iron, lead, nickel, zinc, nitrate, nitrite, total Kjeldahl nitrogen, and ammonia). Area specific predictions from the Final Environmental Impact Statement (FEIS; Baffinland 2012) will be included on the plots for comparison;
- *Tabular summaries of seasonal averages*;
- A statement comparing the concentrations to area specific predictions from the FEIS; and
- Weather data will be corelated with sampling to the extent possible to assess the impact of wet versus dry events on observed monitoring values.

This memorandum will be submitted within 6 months of the approval of this Licence by the Minister. The memorandum will be submitted to the NWB to allow a review of the study outcomes. Baffinland will provide the memorandum to QIA 30 days before the NWB submission to allow QIA to evaluate the conclusions and provide recommendations of updates into suggested management plans. As required, the outcomes of the memorandum will be integrated into relevant management plans. Any plan updates would be completed within 6 months of publication of the memo, or an alternative date as agreed to between QIA and Baffinland.



Commitment 32 in response to concern and/or recommendation by QIA (QIA-TR-2):

Where professional judgement is applied in relation to Trigger Action Response Plans (TARPs), Baffinland will include supporting rationale. Baffinland to further provide a clearer linkage of how exceedances of objective TARP thresholds will result in management actions of project effects pathways. This will be provided regularly (when used) in Annual Reports.

Commitment 33 in response to concern and/or recommendation by QIA (QIA-TR-2): Baffinland will update the AEMP to include event-based water quality monitoring

informed by the QIA-TR-1 memorandum conclusions, or other relevant data. The AEMP will define how an event is triggered and assessed. This will be submitted in the form of Management Plan Update within 6 months of the approval of the Water Licence.

Commitment 34 in response to concern and/or recommendation by QIA (QIA-TR-6):

Baffinland will collect supplemental baseline data to support the development of applicable aquatic monitoring programs along the Steensby Railway alignment and at Steensby Port, to cover a full season's data prior to construction commencing in a given location. If the supplemental baseline data deviates by more than 2 standard deviations from the original baseline, Baffinland will engage with QIA to review the findings and collaboratively develop appropriate updates to the construction monitoring programs, if required, to ensure potential environmental changes are effectively captured and addressed. This will be submitted in the form of Construction Report prior to Steensby construction.

Commitment 35 in response to concern and/or recommendation by QIA (QIA-TR-7):

Baffinland is planning to reactivate the four hydrometric monitoring stations (BR11, BR25, BR96-2 and BR137) along the Steensby Railway corridor in 2025 to supplement existing baseline data collected for the 2012 FEIS. These stations will measure streamflow and help characterize natural variation in hydrological conditions. If the supplemental baseline data deviates by more than 2 standard deviations from the original baseline, Baffinland will engage with QIA to review the findings and collaboratively develop appropriate updates to the construction monitoring programs, if required, to ensure potential environmental changes are effectively captured and addressed. This will be submitted in the form of Construction Report prior to Steensby construction.

Commitment 36 in response to concern and/or recommendation by QIA (QIA-TR-11/17): Baffinland will update the AEMP to provide quantifiable triggers (e.g., exceedances of water quality guidelines or AEMP benchmark values) within the framework. These triggers will lead to specific adaptive management actions to be undertaken in response to exceedances. The management actions for these cases shall be initially investigated following a process defined in the AEMP, and if the investigation determines it, Page 25 of 96



appropriate mitigative actions for the source or the cause of these exceedances will be implemented. Any plan updates would be completed within 6 months following issuance of the renewed Water Licence, or an alternative date as agreed to between QIA and Baffinland. The AEMP will be revised collaboratively with QIA review and input, specifically with regards to triggers for adaptive management actions.

Commitment 37 in response to concern and/or recommendation by QIA (QIA-TR-14/15): Baffinland commits to a one-time submission of usable, sorted data and metadata for statistical analyses by July 31, 2025. The submission will include all the sediment and water quality data collected from Sheardown and Camp catchment (e.g., lake and tributary). QIA's analysis of this data will be completed at their expense. The outcomes of QIA's analysis will be shared with Baffinland in draft for review and to discuss in relation to any further action to be undertaken as part of the adaptive management framework. Following the completion of this process the QIA may publicly disseminate the results of its analysis through the NWB. This will be submitted in the form of raw data by July 31, 2025.

Commitment 38 in response to concern and/or recommendation by QIA (QIA-TR-16):

Baffinland will provide preliminary/interim and final engineering design solutions for the haul road drainage that currently is conveyed through the KM105 dam and eventually into Sheardown tributary into Sheardown Lake for QIA review at a minimum 60 days before the start of construction, in alignment with the Water Licence requirements. Baffinland will provide an initial adaptive design (engineering designs) to QIA for review by July 31, 2025.

Commitment 39 in response to concern and/or recommendation by QIA (QIA-TR-24):

Baffinland will collaborate with QIA to incorporate the outcomes of QIA-led data collection into relevant management plans listed in Part B Item 14 of the Water Licence, and will plan to submit any consequential updates to the NWB with the submission of the 2026 Annual Report. The timing of this commitment is contingent on QIA providing Baffinland with available verified QIA program-led data relevant to project water use and management and/or waste generation and management by the end of September, 2025.

As stated above, Baffinland committed to provide additional data/information to QIA by July 31, 2025, as per Commitments 37 and 38. The Board would like to note that while specific terms are not included within the Licence associated with these commitments, the expectation is that this data/information will be provided to QIA directly in accordance with the committed timelines.

With regards to the unresolved comment (QIA-TR-5), QIA stated that they remain concerned with Baffinland's history of exceeding daily water withdrawal limits from small Page 26 of 96



watercourses with limited withdrawal limits such as from CV-099, CV-087, CV-078. QIA noted that this poses a potential risk to aquatic life and aquatic habitat from short-term water-level drawdown. QIA, however, acknowledged Baffinland's desire to maintain flexibility to support optimal environmental management, specifically as it relates to dust management and control. QIA recommended to the Board to remove water withdrawal locations with seasonal restrictions from Table 2-3 of the existing Water Licence to support ongoing dust suppression activities.

Legal Opinion Submission

Appended to the QIA's final written submission were legal opinion submissions in relation to two topics. The first topic addressed whether the NWB has the jurisdiction and authority to incorporate Inuit Qaujimajatuqangit and Inuit Qaujimaningit into the water licence and the second discussed the authority and mechanisms for the NWB to include obligations in relation to cumulative effects assessment, management and monitoring into the Renewed Water Licence.

In the first opinion, QIA argued it would be consistent with the NWB's obligations under the *Nunavut Agreement* and *NWNSTRA* to have express terms and conditions incorporated into the Renewed Water Licence to require the Licensee to update management plans upon receipt of Inuit Qaujimajatuqangit and Inuit Qaujimaningit. In support of this conclusion, the QIA highlighted the special role of Inuit knowledge and tradition in the NWB's work, the requirement of the NWB to integrate Inuit Qaujimajatuqangit into its decision-making, and the NWB's duty to give Inuit interests special consideration. The opinion referenced examples of water licence conditions from existing NWB licenses and water licenses in other jurisdictions where these requirements could be added that the QIA viewed as being analogous. The QIA cited these examples as supporting their requested additions to the Renewed Licence.

The opinion concluded with the acknowledgement that although the Inuit Board Members of the NWB play a significant role by sharing and applying their knowledge in the NWB's decision-making, the QIA urged that this activity alone, was insufficient to ensure the collective interests of Inuit are represented in the NWB decisions.

The focus of the second opinion was in support of the QIA's assertion that the NWB should include an express term and condition that would require Baffinland to update the monitoring and management plans required under the Renewed Water Licence to address approaches to cumulative effects management, monitoring and mitigation efforts. As discussed during the Technical Meeting in December 2024, there is currently a Nunavut Impact Review Board-facilitated development of a Cumulative Effects Assessment Framework as directed by the responsible Ministers in 2024 under an amendment to NIRB Project Certificate No. 005. The second opinion argues there is no jurisdictional overlap with the NIRB which would



prevent the NWB from incorporating a term and condition expressly obligating cumulative effects considerations into the Renewed Water Licence.

The opinion argues the NWB has the jurisdiction to regulate any aspect of the project which may impact Nunavut's waters, and notes that the *Nunavut Agreement* requires the NWB to incorporate the terms and conditions of the NIRB Project Certificate into the water licence and to determine, with the NIRB, how best to implement those terms and conditions. The opinion paraphrases the Yukon Supreme Court to argue the NWB would be abdicating its duty to exercise its jurisdiction if it leaves cumulative effects assessment exclusively to the NIRB.

Crown-Indigenous Relations and Northern Affairs (CIRNA)

Crown-Indigenous Relations and Northern Affairs (CIRNA) administers Crown land and resources and enforces regulatory permits affecting land and water resources in Nunavut, under the following Acts and associated regulations:

- Department of Crown-Indigenous Relations and Northern Affairs Act; 12
- Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement);
- Nunavut Waters and Nunavut Surface Rights Tribunal Act (NWNSRTA); 13
- Territorial Lands Act; 14 and
- Arctic Waters Pollution Prevention Act. 15

As set out under the *NWNSRTA*, CIRNA is responsible for enforcing the provisions of water licences issued by the NWB, and specifically, the terms and conditions of the Applicant's existing Water Licence No: 2AM-MRY1325.

CIRNA participated in all phases of the Renewal Application process, providing specialist advice, expert information and knowledge in accordance with the *Nunavut Agreement*. Reflecting CIRNA's responsibilities and jurisdiction, a number of key issues were highlighted in CIRNA's full technical review comment submissions and the same were discussed during the Technical Meeting (TM).

Based on the recommendations CIRNA provided to the Board during the technical review period, and discussions during the TM and Pre-Hearing Conference (PHC), a number of commitments were outlined in the List of Commitments provided within the Pre-Hearing

Conference Decision. ¹⁶ Exhibit 13 – Commitments List from the Public Hearing, March 12, 2025, includes a consolidated list of commitments from the TM/PHC as well as the commitments that were agreed upon by parties during the PH proceedings.

As set out in detail in <u>APPENDIX C: List of Submissions and Correspondence</u>, on February 11, 2025, the NWB received CIRNA's final written submission¹⁷ summarizing CIRNA's outstanding recommendations. CIRNA also attended and made presentations during the technical and community sessions at the in-person Public Hearing for the Renewal Application in Pond Inlet on March 11 and 12, 2025, and engaged in further discussions.

CIRNA noted in their final written submission¹⁸ that most of their technical comments have been resolved either by response or by commitments form Baffinland. There were 4 comments or concerns outstanding from their originally submitted 37 technical comments and recommendations. The outstanding concerns were related to the following topic areas:

- Dustfall Monitoring Improvements,
- Mineral Wastes,
- Climate Change Predictions, and
- Water Quality Monitoring.

With regards to dustfall monitoring improvements, CIRNA in their final submission noted that:

CIRNAC recommended a comprehensive review of dustfall monitoring relative to the scope and authority of the WL, relative to water quality, and to consider the following:

a) Review of dustfall data and the model used to support the monitoring program (including sample design, assumptions etc.) to determine if dustfall data collection is sufficient, relative to the current state of development and verify the operations of dustfall performance over time, relative to baseline predictions.

With regards to mineral waste, CIRNA in their final submission noted that:

After the pre-hearing and technical meetings CIRNAC considers this unresolved and recommends BIMC update the waste management plan to include mineral waste and directives for: collection, containment, data / records, and disposal.

With regards to climate change predictions, CIRNA in their final submission noted their recommendation remains that:

BIMC revisit its climate change predictions and evaluate the long-term thermal stability of the permafrost in the WRF. This evaluation also needs to be updated once additional monitoring and modelling data from the WRF are available.

With regards to water quality monitoring, CIRNA in their final submission noted:

CIRNAC recommends that BIMC:

- a) Provide a comparison between predicted and measured water quality data and evaluate if additional mitigation measures are required.
- b) Provide update on geochemical modeling and pit water quality predictions.

At the Public Hearing (PH), CIRNA during their presentation, provided an update on the outstanding concerns and noted that these have since been resolved through commitments by Baffinland. These commitments are as follows¹⁹:

- Baffinland has committed to conducting a dustfall review in the 2025 QIA NWB annual report for operations, which would be submitted on March 31, 2026. The outcomes of the dustfall data review will be integrated into relevant management plans and any updates to the plan would be completed within six months of publication of the dustfall data review or an alternative date mutually agreed upon between Baffinland and CIRNAC.
- Baffinland has committed to update the ICRP to include soil or sediments containing site-related contaminants that pose a risk to human health and/or the environment.
- Baffinland has committed to include multiple climate change projections, including SSP1, SSP2, and SSP5 into their next update of the thermal model planned for 2026.
 This is also outlined in the Interim Closure and Reclamation Plan Revision 6.
- Baffinland has committed to undertaking a pit water quality model in 2025. This model will include the following: An operational pit water quality prediction for the next five years; a water quality prediction for early closure scenario at the end of these five years, which will consider three different climate change scenarios for a hundred-year period. Additionally, in this model exercise, water quality predictions for early closure scenarios will be compared against closure objectives and criteria. This is outlined in Table 5.1 of Baffinland's Interim Closure and Reclamation Plan Revision 6. The five-year operational water quality predictions will be evaluated against the FEIS predictions and the type A water licence discharge criteria.

The following commitments were agreed upon by Baffinland and CIRNA during the PH as a result of their discussions on unresolved comments/concerns:

Commitment 28 in response to concern or recommendation by CIRNA (CIRNAC R-04): Baffinland commits to conducting a review of dustfall data and the associated monitoring program to assess the following:

- Sample design
- Program assumptions
- Data Collection
- Dustfall relative to baseline predictions.

This will be submitted in the form of Dustfall Data Review Report by March 31, 2026.

Baffinland commits to conducting the dustfall review described above as part of the 2025 QIA/NWB Annual Report for Operations, to be submitted by March 31, 2026. As required, the outcomes of the dustfall data review will be integrated into relevant management plans. Any plan updates would be completed within 6 months of publication of the dustfall data review, or an alternative date as agreed to between CIRNAC and Baffinland.

Furthermore, as outlined in response to QIA-TR-1, Baffinland will develop a memorandum that will assess temporal water quality trends in relation to relevant FEIS predictions. This memorandum, combined with the dustfall review data will inform future updates to relevant management plans. This will be submitted in the form of Management Plan Updates by September 30, 2026.

Commitment 29 in response to concern or recommendation by CIRNA (CIRNAC R-08): Baffinland will update the ICRP to include soil or sediments containing site related contaminants that pose a risk to human health and/or the environment. A contaminant is defined as any substance that, when introduced into the air, water, soil or sediment, exceeds an agreed upon end land use or other criteria developed as part of the closure planning process and has the potential to cause adverse effects to human health, the environment or ecological systems. This will be addressed in the next ICRP Revision.

Commitment 30 in response to concern or recommendation by CIRNA (CIRNAC R-16): Baffinland will undertake a pit water quality model update in 2025. This model will include the following:

- 1. Operational pit water quality predictions for the next 5 years (2025-2029).
- 2. Water quality predictions for an early closure scenario at the end of 2029, considering three different climate change scenarios for a 100-year period.



It should be noted that this model is being completed to provide data requested by CIRNAC and QIA regarding pit water quality predictions to support closure security estimation.

As part of this modelling exercise, water quality predictions for the early closure scenario will be compared against closure objectives and criteria, which are outlined in Table 5.1 of Baffinland's Interim Closure and Reclamation Plan Revision 6. The 5-yr operational water quality predictions will need to be evaluated against FEIS predictions and type A Water Licence Discharge Criteria.

The model will be completed by Q4-2025 and is scheduled to be submitted as part of the Annual Security Review process.

The final agreed upon commitments along with their respective timelines and form of submission are also listed in Exhibit 13 – Commitments List from the Public Hearing, March 12, 2025.

CIRNA further added that they are committed to working with Baffinland and the QIA towards a signed Security Management Agreement (SMA) that would be completed in time for the Minister to review the Renewed Licence. Following CIRNA's presentation, the NWB asked CIRNA to confirm that at this Public Hearing for the Renewal Application, no changes are contemplated or requested by the parties to the existing security provisions under Part C and Schedule C of the Licence. CIRNA confirmed that they do not expect any changes to Schedule C, and that they are dedicated to having this [SMA] done in time for the Minister's signature of the Licence.

Environment and Climate Change Canada (ECCC)

The focus of Environment and Climate Change Canada's (ECCC) involvement in respect of the Renewal Application is based on their jurisdiction under the *Department of the Environment Act*, ²⁰ Canadian Environmental Protection Act, 1999, ²¹ Fisheries Act, ²² Migratory Birds Convention Act, ²³ and Species at Risk Act. ²⁴

ECCC has general responsibility for environmental management and protection; preservation and enhancement of water, air and soil quality; conservation and protection of migratory birds, species at risk, flora and fauna; the gathering and provision of meteorological information; coordination of various specific environmental policies and programs; and enforcement of the pollution prevention provisions of the *Fisheries Act*.

ECCC participated and provided specialist advice, expert information and knowledge in all phases of the Renewal Application process. A number of key issues and concerns were highlighted and discussed in ECCC's initial comment submissions on the completeness of the Renewal Application, in their full technical review submissions, and in their submissions and discussions at the TM/PHC. A list of topics related to the key issues was provided within the PHC Decision Report.

Based on the recommendations ECCC provided to the Board during the technical review period, and discussions during the TM/PHC, a number of commitments were agreed upon to resolve the highlighted concerns. These were outlined in the List of Commitments provided within the PHC Decision.²⁵ Exhibit 13 – Commitments List from the Public Hearing, March 12, 2025, include a consolidated list of commitments from the TM/PHC as well as all commitments that were agreed upon by parties during the PH proceedings.

As set out in detail in <u>APPENDIX C: List of Submissions and Correspondence</u>, on February 5, 2025, the NWB received ECCC's final written submission²⁶, summarizing their comments on the Renewal Application received throughout the NWB's process. ECCC also attended and made presentations during the technical and community sessions at the inperson Public Hearing for the Renewal Application in Pond Inlet on March 11 and 12, 2025, and engaged in further discussion of outstanding issues at that time.

In their final written submission²⁷, ECCC identified outstanding items for the Board's consideration and provided recommendations with respect to impacts of total suspended solids along the Tote Road, water management, impacts of pit flooding, and changes proposed by Baffinland in the Draft Water Licence Framework. At the Public Hearing, ECCC presented²⁸ and provided an update on the status of the outstanding concerns. ECCC also noted that they have been working with Baffinland after their final written submission which has resulted in resolution of some of their outstanding concerns by commitments.

With regards to surface runoff management at Mine Site, ECCC in their final submission stated that:

ECCC recommends the Proponent implement the proposed measures to reduce the sediment load of surface runoff managed on site as promptly as possible. ECCC recommends the Proponent return the effluent discharge and seepage from the

KM105 management pond through a final discharge point (MS-11) before the 2025 spring freshet so the effluent sampling data can be recorded in the ECCC Mine Effluent Reporting System (MERS) online database and so that the water quality can be reviewed to verify compliance with the MDMER. If the plan is to move the MS-11 final discharge point from its current approved location to one further downstream, the Proponent should request this through MERS with a 60-day notice in accordance with the stipulations of the MDMER.

ECCC in their presentation at the Public Hearing noted²⁹ that their recommendation is for Baffinland to implement the measures proposed in their follow-up report on Spill Number 2024-151. Until it can be fully implemented, seepage from KM105 pond should be returned to the pond to be discharged through final discharge point MS-11. Since Baffinland have committed to comply with the MDMER in their response to final written submission, ECCC considered this comment resolved.

With regards to incorporation of water-related management plans into the Water Licence, ECCC indicated:

ECCC recommends that prior to the public hearing the Proponent updates SWAEMP incorporating elements of the Snow Management Plan.

ECCC in their presentation noted that there are two parts to this comment; the Tote Road monitoring program, and the Snow Management Plan. ECCC recommended the Tote Road monitoring program to be added to the Surface Water and Aquatic Ecosystem Management Plan (SWAEMP), however Baffinland has committed to incorporating details from the program, rather than the entire program. The second part addresses the Snow Management Plan that also contains elements relevant to water management on-site and should be incorporated in SWAEMP. Baffinland has agreed to incorporate the Snow Management Plan into the SWAEMP within six months of issuance of renewed Licence and hence ECCC considers this part of the comment resolved.

With regards to criteria for project-related Total Suspended Solids' (TSS) impacts along Tote Road, ECCC indicated:

ECCC recommends that when the Tote Road Monitoring Program is appended to the SWAEMP, the definition of a project-related change in TSS concentrations be modified to mirror the CCME guideline: "Maximum increase of 25 mg/L from background levels at any time when background levels are between 25 and 250 mg/L. Should not increase more than 10% of background levels when background is >250 mg/L."

With regards to permafrost and hydrogeological modelling, ECCC stated that:

ECCC recommends the Proponent identify the data that is missing for an assessment of the impacts of pit flooding on permafrost and the regional hydrogeology. ECCC recommends the Proponent update the reclamation research program on pit flooding to include the collection of missing data identified above, and that the Proponent then assess the impacts of pit flooding on regional hydrogeology.

ECCC noted in their presentation that Baffinland has provided a commitment to update the ICRP that addresses their concerns and hence considers this resolved.

The following commitments were agreed upon by Baffinland and ECCC during the PH as a result of their discussions on unresolved comments/concerns:

Commitment 26 in response to concern and/or recommendation by ECCC (ECCC-04):

As part of the ongoing ICRP research, Baffinland commits to assessing the potential impacts of pit development on local permafrost and hydrogeological regimes prior to pit development to define closure requirements. The details will be further refined as part

Commitment 27 in response to concern and/or recommendation by ECCC (ECCC-04): Baffinland will conduct a review of the Tote Road Monitoring Program (TRMP) data to confirm the natural variability in the 150-metre sample area. Baffinland will share this data with ECCC, which will be used to build the trend of the Total Suspended Solids criteria to be implemented.

ECCC provided a final update on the status of their technical comments and noted that two of their comments remain unresolved; ECCC-2 and ECCC-3 which are connected. ECCC noted that Tote Road Monitoring Program uses project-related change as a criterion to trigger management actions to reduce sediment entering the streams however these changes are defined as twice the CCME Guideline. ECCC recommended incorporating Tote Road Monitoring Program into the SWAEMP and project related change in TSS concentrations should follow the CCME Guideline. In addition, ECCC also provided a number of comments on the Draft Licence Renewal Framework some of which are considered resolved by commitments. ECCC outlined those in their presentation for the consideration of the Board.

Fisheries and Oceans Canada (DFO)

The focus of Fisheries and Oceans Canada's (DFO) involvement in respect of the Renewal Application is based on their jurisdiction under the *Fisheries Act* and the *Species at Risk Act*.



DFO participated in all phases of the Renewal Application process, providing specialist advice, expert information and knowledge. The following key issues were highlighted in DFO's initial comment submissions on the completeness of the Renewal Application, in their full technical review comment submissions, and in their submissions at the Technical Meeting (TM):

- Management Plans, including Surface Water and Aquatic Ecosystem Management Plan and the Road Management Plan be updated to include clear provisions for fish movement through watercourse crossing structures;
- At a minimum, supporting information should include:
 - o locations where road infrastructure interacts with waterbodies and watercourses including seasonally wet drainages;
 - o type of crossing proposed (bridges and culverts);
 - o fish species present, and life stage; and
 - o whether there are fish bearing waterbodies downstream and/or upstream of the crossing and known important habitat. The seasonal channels between fish bearing waterbodies should be considered fish habitat;
- Watercourse crossings; and
- Sediment and erosion control.

As set out in detail in <u>APPENDIX C: List of Submissions and Correspondence</u>, on February 5, 2025, the NWB received DFO's final written submission³⁰, summarizing their comments on the Renewal Application received throughout the NWB's process. DFO also attended and made presentations during the technical and community sessions at the inperson Public Hearing for the Renewal Application in Pond Inlet on March 11 and 12, 2025, and engaged in further discussion of outstanding issues at that time.³¹

In their final written submissions, DFO stated that they had two technical comments related to the potential impacts from watercourse crossings and sedimentation and erosion. These matters were addressed by Baffinland with commitments that include updates to the SWAEMP to include all the watercourse crossings and additional details as well as providing Erosion and Sediment Control Awareness training.

With regards to watercourse crossing, DFO noted during their presentation³² at the Public Hearing that DFO had requested a table of watercourse crossings be added to the SWAEMP. Since Baffinland has proposed to update the table, DFO considers this resolved with the

commitment that the plan will be updated within six months of the approval of Renewed Water Licence.

With regards to concerns related to sedimentation and erosion, DFO stated that they are satisfied with the commitment from Baffinland to implement erosion and sediment control awareness training program for the second quarter of 2025. DFO noted they are satisfied with this commitment and hence considers their comment resolved.

Baffinland Iron Mines Corporation (Baffinland, Applicant or Licensee)

Responses to Issues Raised by Interveners

During the licensing process, Baffinland was fully engaged and participated actively by responding to Information Requests on the completeness check of the Application as well as during the technical review period. Baffinland also engaged actively with all parties during the TM/PHC phase of the Application by providing additional information related to concerns raised by the Interveners and providing a List of Commitments to resolve a number of issues. A list of commitments resulted from discussions during the TM/PHC is included in the PHC Decision for the Renewal Application issued on December 19, 2024. In the final submission, ³³ Baffinland responded to the concerns outlined by the Interveners in their respective final written submissions. For detailed information and discussion on Baffinland's response to each of the technical comments, please refer to Baffinland's submission that can be found on the NWB's Public Registry.

During their presentation at the Public Hearing, Baffinland provided updates on the status of technical comments submitted by the Interveners. Baffinland noted that QIA submitted 38 technical comments as of the most recent update, 11 comments remained unresolved. Baffinland also acknowledged QIA's revised submission of February 28, 2025, that reversed the resolution status on 12 comments related to support for the ISP. Baffinland, during their presentation, reaffirmed their position related to the funding of the ISP and noted that they expect the comments will be resolved through commitments pending agreement with QIA on language. Baffinland, in addition to existing commitments, also provided a technical memorandum on water quality (QIA-TR-1), rationale for professional judgment use (Technical Comment 2), and updates to the AEMP (Technical Comments 2, 11, and 17).

With regards to technical comments submitted by CIRNA, Baffinland provided an update stating that all but four comments have been resolved, and that they are still working on addressing the remaining issues. With regards to technical comments by ECCC, Baffinland highlighted that there were four outstanding comments and that they have resolved three of the four outstanding issues. Baffinland noted that DFO submitted two technical comments,

both of which were resolved through commitments as a result of discussions during Technical Meeting.

Parties were given a chance to ask questions following Baffinland's presentation. QIA asked Baffinland to clarify the source of their claim that the red iron ore dust was naturally present on the land before the mine existed as mentioned by Inuit. Additionally, clarification was sought on whether Inuit have raised concerns about increased dust levels on the land since the mine began operations. Baffinland responded by stating that they have heard from community members about the naturally occurring red soil in the Mary River area during spring runoff, long before the mine existed but concerns have since been raised about dust from the operating mine. Baffinland further stated they are actively working to reduce dust emissions and monitor environmental impacts. Their studies to date indicate limited to no significant changes from baseline environmental conditions.

Baffinland provided an update on the three exhibits submitted by the end of PH. The first document submitted was the disposition table, which includes a final round of technical comments from reviewers and Baffinland's responses. This document also reflected the updated resolution status as well as added new commitments to reflect the discussions that have happened before and during the PH. The second document submitted as exhibit was the final list of commitments as agreed upon by respective parties resulting from discussions during the PH. The third document submitted was a final version of the Draft Water Licence Framework that included parties' comments and recommendations.

During the final closing remarks at the PH, Baffinland stated that almost all of the outstanding comments by the QIA have been resolved. Baffinland asked for confirmation from QIA on revised wording and additional commitments. Baffinland confirmed their support for the ISP and acknowledged that it is a valuable initiative to add to the existing multifaceted programs to incorporate Inuit feedback and IQ into their Project. Baffinland also confirmed with QIA that comments related to Inuit engagement, water rights, and cumulative effects are now addressed and other unresolved technical comments have been resolved as well by Baffinland providing additional information and commitments. In summary, 36 out of 37 total technical comments have been resolved, with no further changes recommended to the Water Licence related to the IQ and the cumulative effects framework.

Draft Water Licence Framework

As a standard practice, Baffinland filed their version of the Draft Water Licence Framework, in which the Applicant provided recommendations regarding renewal to the existing Licence that they consider to be appropriate and necessary to reflect the proposed changes to the Project.³⁴ Parties had a chance to review the Draft Water Licence Framework and provide

their comments, Baffinland was able to submit their responses before going to the Public Hearing.

For the benefit of those unfamiliar with the Board's approach to these documents, it is important to emphasize that although the Board reviews and considers the Draft Water Licence Framework and comments of parties, the suggested changes or updates to the Water Licence provided by parties are not binding on the Board. The Board considers the Draft Water Licence Framework and associated comments, in the same way as any other evidence and retains the discretion to determine what are the appropriate terms and conditions of any given water licence or renewal to an existing water licence.

In recent years the Board has started inviting the Draft Water Licence Frameworks to be submitted, as it is a useful tool to focus parties' discussions on the specific details of updated terms and conditions that may be required to reflect the full scope of an application as well as changes and/or updates suggested by the Applicant and other parties. However, the Board retains their full discretion to determine what specific changes or updates are required to the existing terms and conditions of the Water Licence.

In <u>SECTION VII</u>, the Board discusses its recommended updates to the Water Licence terms and conditions. This section includes a brief explanation of how the Board considered and, where applicable, incorporated the recommendations from the Applicant and other parties in the Draft Water Licence Framework.

SECTION III: SUBMISSIONS BY OTHER INTERVENING PARTIES OR MEMBERS OF THE PUBLIC

There were no written submissions provided to the NWB by any other intervening party or members of the public. On the evening of March 11, 2025, as part of the in-person Public Hearing, a Community Information Session was held by the Board, and community Representatives from Arctic Bay, Clyde River, Sanirajak (Hall Beach), and Igloolik and community members from Pond Inlet in attendance were invited to question Baffinland and any of the Interveners. Community members were also invited to share relevant knowledge with the Board and provide any comments or express any concerns they may have with respect to the Renewal Application. For more detail regarding attendees from the community, **APPENDIX D- Sign-in Sheets – List of Participants in the Public Hearing** provides the sign in sheets for the Public Hearing, including the Community Session, and the Record of Proceedings identifies the Community Representatives from Arctic Bay, Clyde River, Sanirajak (Hall Beach), and Igloolik that attended the Public Hearing.

For the convenience of reviewers, the Board has prepared the table that follows to provide a brief, high-level summaries prepared by staff of key issues raised by community members

in attendance during the Public Hearing and Community Information Session. Please note that the Table includes issues raised by the communities that extend beyond the NWB's jurisdiction and that may not be directly relevant to the NWB's consideration of the Renewal Application (for example, topics such as marine mammal abundance) and that are outside the NWB's jurisdiction. However, as these issues may be relevant to Baffinland, Interveners, researchers or other members of the public with an interest in the Mary River Project, the NWB has included these issues in the summary table. It should also be noted that the summaries are edited for brevity, not exhaustive and not verbatim, and parties interested in a review of all comments as received in their entirety are advised to consult the transcripts for the Public Hearing available on the NWB's Public Registry.³⁵

Are there safety issues being created by these changes within the project area (especially where the railroad will be constructed)? Communication with the Communities	Some of the information being presented by technical advisors is not widely known by the community members and it seems the technical advisors also may not know the information being provided by community members. Communication with the Communities	Communities could use more time and should have access and funding for technical advice so that we can understand the nature and content of the technical comments that the NWB has received about the Application so far.

Dam at KM105 Lake	What is Baffinland referring to when they talk about the dam at KM105 Lake? Are there fish affected by that dam?
Dust	There used to be dust monitoring committee members in all of the potentially affected communities, but the committees seem to have been disbanded and we want to see these committees and their work continue over the term of this licence.
Dust	Before the dust committee started working there was red dust visible and being spread across the land, but the application of water and other dust suppressants changed things considerably. But we think it is important that Baffinland continue to apply water and dust suppressants to keep the dust down.
Dust	Our community has the same issues with dust as the mine, but vegetation, like berries and lichens, does not seem to be affected; does Baffinland have data regarding the extent to which iron ore dust has different effects on vegetations compared to normal road dust?
Dust	The communities have noticed that the dust disperses far beyond the mine and port developed area and we think that if Baffinland and regulators want to see these effects that the sites outside the developed areas need to be visited.
Elders Committee Input	What kinds of things do the Elders Committees talk about with Baffinland when they are involved?
Fish	Have all of the lakes with landlocked char in the Project area been identified, and when Baffinland conducts monitoring of those lakes can the Hunters and Trappers Organizations receive reports about that monitoring from Baffinland/the Qikiqtani Inuit Association?
Fish	Based on Baffinland's monitoring and observations, have the freshwater lakes with fish in them been impacted? Are you seeing effects on the numbers and health of the char in those lakes when you compare them over time from before the mine (baseline) to today?
Fish	Have there been studies done about the freshwater lakes and the fish health in the lakes near Pond Inlet, especially fish health in Qurluktuk Lake near Pond Inlet?
Funding for HTOs to Participate in NWB Licensing	The North Baffin Hunters and Trappers Organizations should have access to funding to ensure they can have their own legal and technical advisors to participate in the Nunavut Water Board's regulatory processes and to conduct monitoring on their own.
Impacts	Has Baffinland thought about delaying the railway construction until after the caribou quota system is no longer in place and caribou numbers have recovered?
Industrial Developments	Communities need time to get familiar with industrial development and all the potential impacts, Inuit are not familiar with these issues right away and need time to understand and then formulate our questions.

Inuit Qaujimajatuqangit	I want to know from both Baffinland and the Qikiqtani Inuit Association how Inuit Qaujimajatuqangit is applied and used by the parties; we find that we sometimes share our information and knowledge, but then the knowledge holders once they have shared the information no longer remain involved and do not get to see how this information is applied to the Project.
Inuit Qaujimajatuqangit	Did the Federal Departments/scientists/investigators attend the project sites/ and or this Hearing with Inuit from Nunavut? In future, people conducting research at these sites should ensure that Inuit voices are being heard, and Inuit knowledge holders are being consulted, and their knowledge is being considered, not just technical advisors not from here. These knowledge holders have different views and knowledge that must be considered.
Marine Mammals	Near Hall Beach and Arctic Bay there used to be all sorts of walrus in that area, and they used to congregate in the shallow waters in the Foxe Basin area in the summer. They are there feeding on mussels and clams in the ocean bed. We used to observe the migration of the narwhal, walrus and seals and all the marine mammals but they seem to be moving away from something in the summertime now. We don't see seals and walrus in that area in the summertime anymore since the project started because it is now a shipping corridor. The walrus will be moving away from Steensby Inlet when Baffinland starts construction. Baffinland needs to be aware of that. Once walrus move away from their habitat they do not return to their original habitat. The narwhal have moved away from Pond Inlet and are more in the Foxe Basin now, but when shipping moves to Steensby Inlet, the narwhal will move away again.
Monitoring	Does the Qikiqtani Inuit Association conduct any independent studies in relation to organisms in the water to independently identify if there are effects from the Project?
Monitoring	Before the construction of Steensby Inlet will there be additional studies undertaken to identify the conditions at the site before construction and operation of the Steensby Inlet Port?
Monitoring	In addition to baseline studies, are there studies going on about the existing effects of the mine?
Monitoring	Has the Qikiqtani Inuit Association ever considered having a third party conduct independent monitoring to collect baseline information and on-going monitoring data?
Monitoring/ Mapping	Has Baffinland done any monitoring/mapping of the ocean floor in the area near Steensby; there are some shallower areas throughout that area, and we have concerns about vessels becoming stranded.

Steensby Inlet	We would encourage the Interveners to come to Steensby Inlet to see what it is like now before construction and to see what we, as Inuit, see in our communities before construction begins.
Switch from Trucking to Train transportation	What will the difference be (in terms of impacts to wildlife and the land users) when Baffinland switches from trucking to transportation of ore by train to Steensby Inlet?
Term of the Licence	For the impacted communities, we think that the renewal of the Licence for a requested term of 15 years is too long. We think that a term of 10 years seems to be more appropriate so that the NWB can review the Project and Baffinland's compliance under the licence in a shorter time period, especially if the Port at Steensby Inlet is constructed during the term of the renewed licence.
Waste Rock	Are there contaminants that come off the rock and the ore at Mary River (and that could become a constituent of the dust coming off the ore and waste rock piles) at the site?
Water Quality	Does Baffinland monitor the quality of the drinking water around the mine and the port site? Can someone tell me whether the water remains safe to drink?
Water Quality	We want water quality to be preserved for our children and grandchildren. We urge the NWB to not simply rubber stamp the water uses request by Baffinland.
Water Quality Testing	There is a smaller river (Sanikisuaq—phonetic spelling from the transcript) that flows along the project that had bad quality historically (crystals observed and made children sick). Does the Nunavut Water Board or Baffinland or others have any studies about what the cause of the bad water quality is for that water course?

SECTION IV: JURISDICTION OF THE NWB

Under Division 2³⁶ of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, S.C. 2002, c. 10 (*NWNSRTA*) the NWB has jurisdiction to issue a licence,³⁷ amend a licence,³⁸ renew a licence,³⁹ or in certain circumstances, cancel a licence.⁴⁰ In exercising the Board's statutory functions under the *Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (<i>Nunavut Agreement*) and the statutory

regime governing the Board (the *NWNSRTA* and the *Nunavut Waters Regulations*⁴¹), the NWB must be guided by the following objects:

... to provide for the conservation and utilization of waters in Nunavut, except in a national park, in a manner that will provide the optimum benefit from those waters for the residents of Nunavut in particular and Canadians in general.⁴²

In setting the terms and conditions of a licence, the NWB is guided by these objects and the NWB's statutory duty to make *all* reasonable efforts to minimize *any* adverse effects on aquatic ecosystems. Reading several of the Articles of the *Nunavut Agreement* together, ⁴³ the NWB relies on the broad definition of "ecosystemic" found in Article 12, Section 12.1.1. of the *Nunavut Agreement*, requiring not only the Nunavut Impact Review Board (NIRB) but also the NWB to ensure that all components of the ecosystem, such as fish and fish habitat, are protected within the parameters of s. 71 of the *NWNSRTA*.

In accordance with Article 13, Section 13.3.6 of the *Nunavut Agreement* and s. 29 of the *NWNSRTA*, ⁴⁴ the Board delegated the power to dispose of all matters related to the Renewal Application of the existing type A Water Licence No: 2AM-MRY1325, including the conduct of the Public Hearing, to a Panel of the Board (which is referred to as Panel P4 or the Mary River Panel). The duly-appointed Panel P4 consisted of the NWB's Chairperson Lootie Toomasie and Panel Members, Earle Baddaloo and Uriash Puqiqnak.

As with any application considered by the NWB, the burden of proof rests with the Applicant, Baffinland, to demonstrate that their request for renewal to type A Water Licence should be granted, and that the proposed terms and conditions should be granted. In addition, the NWB Rules of Practice state: "[a]ny party offering evidence before the NWB shall have the burden of introducing sufficient and appropriate evidence to support its position."⁴⁵

SECTION V: REQUIREMENTS OF THE NWNSRTA, THE NUNAVUT AGREEMENT AND NUPPAA

Objects of the NWB and its Relationship to other Bodies

As established under the Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement) and Part 3 of the Nunavut Planning and Project Assessment Act, S.C. 2013, c. 14, s. 2 (NuPPAA), prior to the NWB's consideration of the Renewal Application, the Applicant must meet the pre-licensing requirements of the Nunavut Planning Commission (land use planning) and the Nunavut Impact Review Board (impact assessment). As outlined under the Pre-Licensing Regulatory History of the Application section of this Decision, the Renewal Application was considered by the Nunavut Planning Commission, and no referral to the Nunavut Impact Review Board for further impact assessment was considered to be necessary.

Land Use Planning

On May 24, 2024, the Nunavut Planning Commission (NPC) issued its conformity determination ⁴⁶ for the Renewal Application which stated the following:

- The activities associated with this proposal were previously reviewed by the NPC, and conformity determinations were issued on April 30, 2008, August 12, 2011, February 8, 2016, January 26, 2017, May 18, 2018, December 16, 2019, June 7, 2022, and February 2, 2023, which still apply;
- The Nunavut Impact Review Board (NIRB) previously screened and reviewed the activities included in the current Licence (NIRB FILE No. 08MN053, 17UN012, Project Certificate No. 005); and
- The Renewal Application is exempt from screening by the NIRB, because the project proposal does not change the general scope of the original or previously amended project activities, and the exceptions noted in Section 12.4.3 (a) and (b) of the *Nunavut Agreement* do not apply.

On this basis, the NPC indicated that the Renewal Application could proceed to the permitting stage without a referral to the NIRB for further assessment.

Impact Assessment

As noted above, in the NPC's determination, the NPC concluded that the activities associated with the Renewal Application were previously assessed by the NIRB (NIRB File No: 08MN053, 17UN012) and therefore the activities were exempt from requiring further assessment by the NIRB. The NPC's determination also confirmed that the Renewal Application did not constitute any changes to the general scope of the original or previously amended project activities as previously assessed by the NIRB, and the exceptions noted in Section 12.4.3 (a) and (b) of the *Nunavut Agreement* do not apply.

On this basis, the NWB concluded that the applicable pre-licensing conformity and impact assessment requirements for the Renewal Application under Articles 11 and 12 of the *Nunavut Agreement*, Part 3 of the *Nunavut Planning and Project Assessment Act*, S.C. 2013, c. 14, s. 2 (*NuPPAA*) and ss. 38 and 39 of *the Nunavut Waters and Nunavut Surface Rights Tribunal Act*, S.C. 2002, c. 10 (*NWNSRTA*) had been met and the Renewal Application was processed by the NWB.

Inuit Water Rights

Separate from the Inuit Impact and Benefits Agreement (IIBA), the Qikiqtani Inuit Association (QIA) and Baffinland addressed the impacts of the water use and waste deposits associated with the undertaking on Inuit water rights pursuant to Article 20 of the *Nunavut Agreement* and s. 63 of the *NWNSRTA* by way of a specific water compensation agreement. At the Public Hearing, Baffinland confirmed that the existing water compensation agreement with the QIA would continue to govern under a renewed water licence:

...so we do have a water compensation agreement we negotiated in 2013 that remains in effect. We've not re-filed it with this application, but it would be the same document that we'd placed on the record in 2013. ⁴⁷

In questioning by the Board during the Public Hearing, the QIA also confirmed that the existing water compensation agreement would continue to be relied on by the parties to address the impacts of the Project on Inuit water rights:

[NWB]: Can QIA confirm that you have a...valid water compensation agreement with Baffinland...
[QIA] Yes, we can confirm that.⁴⁸

On this basis the Board has determined that the compensation requirements of s. 63(1)(a) of the *NWNSRTA* have been met with respect to the Renewal Application.

SECTION VI: DECISION TO ISSUE

Based on the information and materials provided during the Board's consideration of the Renewal Application, and for the reasons outlined in these Reasons for Decision, the NWB's duly appointed Mary River Panel, Panel P4, has, by **Motion # 2025-01-P4-06**, decided to grant the Renewal Application and issue renewed type A Water Licence No: 2AM-MRY2540 to Baffinland.

The Mary River Panel (P4) by **Motion #2025-01-P4-06** also authorized the release of these Reasons for Decision and Renewed Water Licence No: 2AM-MRY2540 (Renewed Water Licence or Licence). It is the Board's view that the terms and conditions included in the Renewed Water Licence are necessary to protect the environment, conserve freshwater resources, and provide appropriate safeguards in respect of the water uses and waste deposits associated with the Mary River Project.

The Renewed Water Licence continues to authorize the use of water and deposit of waste associated with the construction, operation, reclamation, closure and post-closure monitoring (closure and post-closure monitoring not generally covered under this Licence) of a Mining Undertaking, as defined under Schedule 1 of the *Nunavut Waters Regulations*.⁴⁹

Conditions for Issuance of a Licence

As set out under sections 57, 58, 60, 63 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, S.C. 2002, c. 10 (*NWNSRTA*) and as specifically discussed below, there are a number of conditions that must be met before the Board can consider issuing or renewing a water licence.

Section 57 of the *NWNSRTA* provides several key legislative requirements that must be satisfied before the NWB may issue a licence, as follows:

The Board may not issue a licence unless the applicant satisfies the Board that

- (a) any waste produced by the appurtenant undertaking will be treated and disposed of in a manner that is appropriate for the maintenance of the water quality standards and effluent standards that are prescribed by the regulations or, in the absence of such regulations, that the Board considers acceptable; and
- (b) the financial responsibility of the applicant, taking into account the applicant's past performance, is adequate for
 - $(i)\ the\ completion\ of\ the\ appurtenant\ undertaking,$
 - (ii) such measures as may be required in mitigation of any adverse impact, and

(iii) the satisfactory maintenance and restoration of the site in the event of any future closing or abandonment of that undertaking.

Financial Responsibility of the Applicant

The NWB's assessment of the Applicant's financial responsibility under s. 57(b) is a contextual analysis that considers not only the specific activities in relation to the current Renewal Application, but also the Applicant's overall financial capacity to carry out the Undertaking that is the subject of the Renewed Water Licence. In this regard, recognizing that this is an existing Mining undertaking that has been in operation in some form since 2013, the Board has paid particular attention to the Applicant's past performance and compliance history.

In addition to information received by the NWB in the annual reports provided under the Existing Water Licence, the Board reviewed the specific materials summarizing compliance filed by Baffinland with the Renewal Application:

- The compliance assessment prepared by Baffinland and submitted as Attachment 1 to the Renewal Application;
- The recent (2023 and 2024) inspection reports from Crown Indigenous Relations and Northern Affairs Canada, Field Operations and Baffinland's responses attached as Appendix K1 to the Renewal Application; and
- The 2023 QIA inspections and Baffinland's responses and attached as Appendix K2 to the Renewal Application.

With respect to considering Baffinland's past performance to assess their financial capacity to carry out the undertaking governed by the Renewed Water Licence, the Board notes that:

- Baffinland has constructed and operated the Mary River Project (as modified to reflect the Early Revenue Phase project proposal) commencing in 2013;
- From 2013 to date, Baffinland has demonstrated the financial capacity to carry out the Mining undertaking in accordance with the terms and conditions of the existing Water Licence No: 2AM-MRY1325; and
- There was no evidence put before by the Board by any Intervenors, community representatives or members of the public during the Board's consideration of the Renewal Application that would suggest limits on the financial ability of Baffinland to successfully fulfill the obligations arising from the terms and conditions in the Renewed Water Licence.

On the basis of the financial information provided with the Renewal Application, and with the Board's acknowledgement of Baffinland's prior operating history of the Mary River Project, the Board has concluded that Baffinland has established that they have the financial

capacity to fulfill their responsibilities under the Renewed Water Licence as required by s. 57(b) of the *NWNSRTA*.

Compensation of Existing or Other Users

The *NWNSRTA* requires that the NWB be satisfied that compensation of existing or other water users affected by the Renewal Application has been or will be paid.⁵⁰ To ensure that all parties with the potential to bring a water compensation claim have been notified of their rights under s. 55 of the *NWNSRTA*, the Notice of the Renewal Application issued by the Board on June 27, 2024, and the Notice of Public Hearing, published on December 27, 2024, invited anyone having a water user compensation claim to inform the Board of their interests in accordance with the timeline specified in the Notices. The NWB confirms that other than the representations of the QIA and confirmation by Baffinland regarding Inuit water rights compensation (referenced in the previous section of these Reasons for Decision), no water compensation claims were made to the NWB.

Issuance of a Licence

As stated above and pursuant to s. 42(1) of the *NWNSRTA*, by way of **Motion # 2025-01-P4-06**, the NWB's duly appointed decision-making Panel for the file, Panel P4, has decided to issue renewed type A Water Licence No: 2AM-MRY2540. In issuing the Renewed Water Licence, the NWB is satisfied that the Renewal Application contained the required information and was received in the proper form having regard to the requirements of the *NWNSRTA*⁵¹ and associated Regulations.⁵²

Assumptions

When faced with choices regarding monitoring requirements such as standards or parameters to be imposed under the Licence, the Board has opted to impose stringent monitoring requirements in an effort to ensure that the Applicant meets their on-going environmental protection obligations.

Renewal Application in Relation to the Licence

Overall, the NWB is satisfied that the requirements of s. 48 of the *NWNSRTA* have been met. Baffinland filed a Renewal Application that complied with the NWB's Guide No.4 (*Guideline for Completing and Submitting an Application for a New Water Licence*) and associated *Supplemental Information Guideline (MM3) for Mine Development*, accompanied by the fees required by the *Nunavut Waters Regulations*, including the application fee. In addition, Baffinland has provided the necessary materials to support the Renewal Application and responses to supplementary information requests provided by the Board and

other parties as necessary for the Board to evaluate whether the Renewed Water Licence should be granted.

Application to Amend or Application for Future Modifications

In relation to future applications to undertake significant modifications to the activities included within the scope of the type A Water Licence, the NWB reminds Baffinland that it must comply with all requirements of the *Nunavut Agreement*, ⁵³ the *NuPPAA*, ⁵⁴ and the *NWNSRTA*. ⁵⁵ In particular, the Board notes that the scope of the authorized use of water and deposit of waste is as provided by Baffinland in the Renewal Application and as set out in Part A of the Renewed Water Licence, and any requested changes to that scope may trigger amendments to the Licence. In addition, any significant modifications to the undertaking are required to be submitted to the Nunavut Planning Commission and may subsequently be referred to the Nunavut Impact Review Board for further impact assessment prior to the NWB's consideration of any associated amendments to the Water Licence.

Assignment of the Licence

If Baffinland wishes to assign the Licence, the Board highlights that the licence is <u>only</u> <u>assignable</u> if the requirements of s. 44 of the *NWNSRTA* have been met. This section states:

A sale or other disposition by a licensee of any right, title or interest in an appurtenant undertaking constitutes, subject to the authorization of the Board, an assignment of the licence to the person to whom the sale or other disposition is made.

Cancellation or Expiry of the Licence

As indicated above, the NWB reminds the Applicant that the provisions of s. 46 of the NWNSRTA state: "[t]he expiry or cancellation of a licence does not relieve the holder from any obligations imposed by the licence."

The Applicant is also reminded that pursuant to the NWB's authority under s. 43(1)(c)(iii) of the *NWNSRTA*, the NWB may, on application by a licensee, or on its own motion, cancel a licence at any time if the NWB considers the cancellation to be in the public interest.

Term of Licence

Section 45 of the *NWNSRTA* provides that the term of a type A Licence or any renewal shall not exceed the longer of twenty-five years or the "anticipated duration" of an undertaking (other than an undertaking, for which the maximum term is prescribed by Regulation as 25 years).

The Applicant requested the licence be renewed for a term of 15 years in the Renewal Application, and during the review process, Interveners did not express concerns on the proposed term of licence for renewal. However, during the Public Hearing and Community Session, some members of the Public expressed concerns noting that 15 years is a long time and that the Board should consider a shorter term for the Renewal Application. Community Members indicated that a shorter term of 10 years may be more appropriate to help ensure that if there are problems with compliance or unpredicted impacts on freshwater that these issues will come to light earlier and will not continue until the next renewal application.

The Board understands that the basis for requesting the Board renew the Existing Licence for a shorter term of 10 years is the desire of communities to ensure that Baffinland remains accountable for the protection of freshwater and that situations of non-compliance are addressed promptly before harm to the environment results. The Board notes that the Board and the Interveners involved in the NWB's consideration of the Renewal Application share these objectives. These objectives are, however, addressed with the extensive monitoring and annual reporting requirements in the existing Water Licence and Renewed Water Licence, which ensure that the Board, the land owners, Interveners, including other regulators, CIRNA's field Inspectors responsible for enforcing the terms and conditions of the Renewed Licence and interested members of the public are provided with the information necessary to evaluate compliance and identify issues on a regular basis, not just at the beginning and end of the term of the Renewed Water Licence. As summarized by Baffinland during their closing statement during the Public Hearing:

It's also important to acknowledge that our operations under the licence are subject to regular inspections by Crown-Indigenous Relations and Northern Affairs Canada, and Baffinland has a demonstrated record of compliance.

Baffinland is subject to multiple inspections on the project relevant to our water licence, including those by Environment and Climate Change Canada and the independent inspections that QIA, the Qikiqtani Inuit Association, carries out under the commercial lease. Ever since the licence has been in effect, Baffinland has adjusted its mitigation and monitoring programs based on the feedback received through the annual reporting process or standalone reviews of our management plans.

In each case, these reviews are public and carefully facilitated by the Nunavut Water Board. This is an important factor in our request to the Board to issue a 15-year licence term. The water licence renewal process is not the only opportunity that's provided to make adjustments where needed. Care and attention to these matters is required throughout the licence term, and we have every confidence that all parties will continue to fully participate in and give feedback through standard and expected Nunavut Water Board facilitated reviews. ⁵⁶

Regardless of the length of the term of the Renewed Water Licence Baffinland remains accountable throughout the term of their type A Water Licence for compliance with the terms and conditions, including providing information from Baffinland's freshwater monitoring, management and mitigation programs established under the Water Licence to preserve and protect freshwater. The Board is confident that with the implementation of all of these related terms and conditions in the Renewed Water Licence, the objectives of the community in ensuring on-going compliance and environmental protection throughout the full term of the Renewed Water Licence can be met. Accordingly, the Board has decided to grant the 15-year term requested by Baffinland in the Renewal Application, which will mean that the Renewed Water Licence will expire in 2040.

SECTION VII: WATER LICENCE 2AM-MRY2540 TERMS AND CONDITIONS

The Licence does not take effect until the Minister approves or is deemed⁵⁷ to have approved the NWB's recommendation to issue the Renewed Water Licence. As indicated in <u>SECTION VI</u>, the Panel has decided to issue renewed type A Water Licence No: 2AM-MRY2540, subject to the conditions contained herein.

To provide context and clarity, the NWB has provided a discussion and comments about specific changes and updates to the terms and conditions that follow. The NWB has not, however, provided specific comments for those changes and updates to licence terms and conditions that are clear in their wording and intent on the face of the Renewed Water Licence.

Part A: Scope, Definitions and Enforcement

<u>Scope</u>

The Undertaking, for which the Renewed Water Licence is issued, is classified as a Mining Undertaking in accordance with Schedule 1, Item 2 of the *Nunavut Waters Regulations*. ⁵⁸

The scope of the Renewal Application⁵⁹ remains generally the same as that of the current Water Licence 2AM-MRY1325. No changes were being proposed in terms of scope,

The issuance, amendment, renewal and cancellation of a type A licence, and if a public hearing is held, a Type B licence are subject to the approval of the Minister.

Under s. 56(2.2) if the Minister does not issue a decision within 45 days of receiving the Licence from the Board, (or within 90 days if the Minister has extended the decision-making period by an additional 45 days) the Minister is deemed to have approved the Licence.

location, water use volumes, or deposit of waste. This section of the Licence has been updated with only minor changes to reflect the Renewed Water Licence.

Definitions

Most of the existing definitions have been carried over from the existing Water Licence with only slight modifications to keep these definitions up to date.

Part B: General Conditions

Baffinland submitted a Draft Water Licence Framework⁶⁰ during the licensing process, proposing a number of revisions to the existing Water Licence for the Board to consider including in the Renewed Water Licence.

In support of the Renewal Application, the Applicant submitted a number of Plans/Programs that have been either approved or accepted by the Board⁶¹ with the issuance of the Renewed Water Licence or were previously approved under the Existing Licence. The following documents were approved (accepted) under Part B of the Renewed Water Licence:

- a. Emergency Response Plan (BIM-5000-PLA-0005, Rev 5), December 8, 2020;
- b. Spill Contingency Plan (BIM-5200-PLA-0012, Rev 12), February 28, 2021;
- c. Surface Water and Aquatic Ecosystem Management Plan (BIM-5200-PLA-0009, Rev 7), March 31, 2021;
- d. Fresh Water Supply, Sewage and Wastewater Management Plan (BIM-5200-PLA-0022. Rev 10) March 31, 2023;
- e. Waste Management Plan (BIM-5200-PLA-0013, Rev 9), March 31, 2023;
- f. Hazardous Materials and Hazardous Waste Management Plan (BIM-5200-PLA-0007, Rev 7) April 20, 2024;
- g. Aquatic Effects Monitoring Plan (BIM-5200-PLA-0023, Rev 2), March 31, 2024;
- h. Environmental Protection Plan (BIM-5200-PLA-0003, Rev 2), April 30, 2021;
- i. Borrow Pit and Quarry Management Plan (BIM-5200-PLA-0025, Rev 0), March 20, 2014;
- j. *Interim Closure and Reclamation Plan* (BIM-5200-PLA-0026, Rev 5) October 2018:

- 1. Phase 1 Waste Rock Management Plan (BIM-5200-PLA-0029, Rev 4.1), April 2, 2024; and
- m. Life-of Mine Waste Rock Management Plan (BIM-5200-PLA-0030, Rev 0), April 30, 2014.

The NWB notes that the Board's approval or acceptance of a plan does not imply that the NWB has considered, or has otherwise approved elements of that plan that may be outside of the NWB's jurisdiction. In addition, reflecting the scale and scope of the future changes to an approved plan, the Board may subsequently process the changes as solely an amendment to the plan, as a Modification under Part G of the Licence, or, if the proposed changes are significant, as an amendment to the Water Licence.

Item 14 requires the Licensee to implement the plans as approved by the Board in writing and lists a number of plans that have been approved/accepted under this Licence or carried forward from the Existing Licence. QIA in their comment on Draft Water Licence Framework suggested including an option to add any management plans that may be relevant in the future, such as an adaptive management plan. Baffinland opposed this suggestion by QIA and noted that the function of the list is to establish the specific management plans that require Board's approval under the Water Licence and that there are many plans relevant to the Project that do not and should not require the Board's approval. ECCC recommended that the Tote Road Monitoring Program should be included as a stand-alone plan or incorporated as an annex to an existing plan [SWAEMP]. Baffinland stated that SWAEMP will be updated with relevant aspects of the Tote Road Monitoring Program and hence it is not necessary to include it as an annex or stand-alone plan. The Board agrees with Baffinland's position and requires the Licensee to update the SWAEMP with relevant aspects of the Tote Road Monitoring Program within 6 months of the approval of the Renewed Water Licence.

The Board added a new condition as Item 15 requiring the Licensee to submit to the Board for review updated management plans to reflect the proposed changes and to take into account commitments made during the technical review of the Application and Public Hearing process. The following plans are required to be updated within their respective timelines:

- Surface Water and Aquatic Ecosystem Management Plan (SWAEMP), to be submitted within six (6) months following the approval of the Licence;
- Aquatic Effects Monitoring Plan (AEMP), to be submitted within six (6) months following the approval of the Licence;
- Fresh Water Supply, Sewage, and Wastewater Management Plan, to be submitted with the 2025 Annual Report; and

Interim Closure and Reclamation Plan (ICRP), to be submitted by November 1, 2026.

During the Board's consideration of the Application, the QIA requested that the Board consider amending the Existing Water Licence to clearly require the Licensee to ensure that the results of Inuit Qaujimajatuqangit and Inuit Qaujimaningit (collectively IQ) studies and Inuit-led and community-led monitoring are incorporated into the Water Licence in general, and specifically requesting the results of such studies and monitoring be considered and incorporated into relevant management plans required under the Water Licence. As outlined in Section II, QIA's Final Submissions of this Decision, the QIA also provided a legal opinion submission to argue that the Board has jurisdiction to add this kind of term and condition to a Renewed Water Licence, and provided samples from existing NWB Licences and other jurisdictions illustrating the type of additional term and condition that would be appropriate.

During the Public Hearing, after focused discussions on this issue outside the hearing, Baffinland and the QIA, in their closing submissions indicated to the Board that they had come to agreement in relation to revisions to the existing term and condition in Part B, Item 17 and two additions to Schedule B (Items 26 and 44 – discussed in more detail in Schedule B) designed to address QIA's request.

In their closing statement, Baffinland indicated the following:

...Baffinland and QIA have now agreed ... on wording for Part B Item 17, and Schedule B, along with Commitment 27 that will require Baffinland to consider outcomes for the Inuit stewardship plan and assessments.

Baffinland understands that QIA technical comments relating to Inuit Qaujimanituqangit [sic Qaujimajatuqangit], Inuit water rights, Inuit engagement, and cumulative effects. Specifically, the QIA comment -- or, sorry, the Qikiqtani Inuit Association Comments numbered 24 and 27 through to Comment 37 are now considered resolved.62

Baffinland subsequently confirmed the QIA's agreement with these revisions as follows:

[Baffinland] Can QIA also please confirm the following: That all recommendations offered by the Qikiqtani Inuit Association in relation to Technical Comment 24 and 27 to 37 during the presentation made by the Qikiqtani Inuit Association yesterday are now resolved by Commitment 27, the revised wording for Part B, Item 17, and Schedule B of the water licence, as well as Baffinland's agreement related to the Inuit stewardship program?

Further to this, the QIA is no longer recommending any other changes to the licence relating to Inuit Qaujimanituqangit [sic Qaujimajatuqangit] and the cumulative effects framework?⁶³

[QIA] ... Assol Kubeisinova, Qikiqtani Inuit Association. Yes, we confirm. ⁶⁴

As set out in Exhibit 14⁶⁵ Baffinland and the QIA proposed the following revisions to Part B, Item 17 of the Existing Water Licence (additions shown in underlined text and deletions shown in strike through text) to address this issue:

B17. The Licensee shall annually review and where appropriate, modify the Plans and or Manuals referred to in this Licence as required by changes in operation, technology, modify and/or the findings of applicable studies, monitoring, and assessments. The Plans or and Manuals shall incorporate design changes, adaptive engineering required and implemented during construction, operation and closure, changes to monitoring strategies and changes to management strategies, on the basis of actual site conditions, monitoring and assessment results, including proponent led, community-led and QIA-led monitoring and studies, over the life of the Project. Revisions to the Plans or Manuals are to be submitted in the form of Addenda to be included with the Annual Report required by Part B, Item 4, complete with a revisions list detailing where significant content changes are made. For reference, the current list of Plans listed at Schedule K to this Licence shall be updated by the Board following approval of any Revisions to the plans approved under Part B, Item 15.

The Board agrees that it is in all parties best interests to not only collect, share, apply and report to the Board and public regarding how any relevant IQ (both Inuit Qaujimajatuqangit and Inuit Qaujimaningit) studies and results of any Inuit-led or community-based monitoring in relation to the licensed undertaking and within the scope of activities in the Water Licence have been considered and incorporated into Baffinland's carrying out of the undertaking throughout the project lifecycle. The Board also understands that, at this point in the development of the Mary River Project, Baffinland and the QIA anticipate that studies and monitoring initiatives under the Inuit Stewardship Program will likely be central sources of IQ and Inuit-led monitoring, but Baffinland indicated that they also have other existing programs to solicit and incorporate Inuit feedback into the project. The Board notes that many of these programs will be developed and implemented outside of the NWB's regulatory processes, and during the Board's consideration of the Renewal Application, the Board heard that initiatives were underway to study freshwater and fish health, but that these studies were

not yet available for the Board's consideration when the Public Hearing Record closed on March 12, 2025. Consequently, the Board must rely on the Licensee who is aware of the various initiatives, studies and programs to:

- Identify when relevant IQ and monitoring information has been generated and shared with Baffinland; and
- Explain how that knowledge and information has been incorporated by Baffinland into the Project (specifically highlighting relevant changes to Plans and Manuals or other mitigation and monitoring activities within the scope of the Water Licence).

As discussed in more detail in relation to the additions to Schedule B, Baffinland's proposed revisions would add this type of reporting to the Licensee's annual reporting obligations. The Board agrees that these additions to the annual report will provide transparency and accountability to the Board, interested parties and the public to ensure that relevant IQ and monitoring information resulting from the various initiatives, studies and programs that are currently planned and that may arise during the term of the Renewed Water Licence are identified and the Licensee's approach to incorporating this knowledge and information is explained.

Consequently, the NWB has, in substance, adopted the proposed revisions to Item B17. However, the Board wishes to highlight that because the Board has not accepted the requested change to adding a separate listing of Plans in a suggested new Schedule K, the Board has modified the last sentence in Part B, Item 17. The revised Part B, Item 17 in the Renewed Water Licence reads as follows:

The Licensee shall annually review and where appropriate modify the Plans and Manuals referred to in this Licence as required by changes in operation, technology, and/or the findings of applicable studies, monitoring, and assessments. The Plans and Manuals shall incorporate design changes, adaptive engineering required and implemented during construction, operation and closure, changes to monitoring strategies and changes to management strategies, on the basis of actual site conditions, and monitoring and assessment and studies results, including proponent led, community-led and QIA-led monitoring and studies, over the life of the Project, relevant to the Water Use and Management/ Waste Disposal and Management. Revisions to the Plans or Manuals are to be submitted in the form of Addenda to be included with the Annual Report required by Part B, Item 4 [Part B, Item 2 of the Renewed Water Licence], complete with a revisions list detailing where significant content changes are made.

The remainder of the revisions to the General Conditions section have been included by the Board to ensure that the terms and conditions of the Renewed Water Licence in this Part are



consistent with the other type A Water Licences applicable to Mining Undertakings previously issued by the NWB.

Part C: Conditions Applying to Security

No revisions to Part C and Schedule C (Security provisions) of the existing Water Licence were requested by Baffinland or the Interveners.

However, Baffinland, the Qikiqtani Inuit Association (QIA) and Crown-Indigenous Relations and Northern Affairs (CIRNA) confirmed during the Public Hearing that they were working together to enter into a Security Management Agreement (SMA) that will, in future, govern how the overall reclamation security (the global security amount) for the Mining Undertaking will be allocated and accessed by the QIA, under their commercial land lease, and CIRNA, under the applicable water licence.

Although the parties indicated that the negotiations between the parties in relation to the SMA had not been concluded as of the Public Hearing, the parties confirmed that they anticipated negotiations would be completed and a signed SMA would be provided to the Minister following the NWB providing the Minister with these Reasons for Decision and Renewed Water Licence for his/her consideration.

Once a SMA has been finalized and signed by Baffinland, the QIA and CIRNA, the NWB is bound by s. 76.1 of the *NWNSRTA* to consider the agreement when fixing the amount of security that must be held under the Renewed Water Licence in accordance with the process established under Part C and Schedule C of the Renewed Licence, as follows:

Arrangements relating to security

- 76.1 (1) If a licence is in respect of an appurtenant undertaking that is situated, partially or wholly, on Inuit-owned land, the Minister may enter into a written arrangement with the designated Inuit organization and the applicant, licensee or prospective assignee of the license that provides for
 - (a) the amount of security to be furnished and maintained by the applicant, licensee or prospective assignee, as well as the form and nature and any conditions of the security, for the purpose mentioned in paragraph 76(2)(b) or for the purpose of reimbursing the designated Inuit organization for the costs specified in the arrangement; and
 - (b) the periodic review of the security, including by taking into account any material changes to the undertaking or the risk of environmental damage, and the adjustment of the amount of the security as a result of the review.



Copy of arrangement to be provided to Board

(2) The Minister shall, as soon as possible after entering into the written arrangement described in subsection (1), provide a copy of it to the Board.

Arrangement to be taken into account under subsection 76(1)

(3) The Board shall take into account the written arrangement when it determines the amount of the security required to be furnished and maintained by the applicant, licensee or prospective assignee under subsection 76(1).

While the Board would have preferred that an executed SMA was in place for the Board's consideration prior to the Board's closing of the Public Hearing Record, as this did not happen, the parties confirmed that there are no requested amendments to the Security provisions in Part C and Schedule C of the existing Water Licence in the Renewed Licence, and it is anticipated that the SMA will reflect the existing structure in the Renewed Licence.

Baffinland indicated the following:

At the technical meeting, Baffinland and other parties did express interest and intent to revisit Part C and Schedule C of the water licence relating to the annual security review process. We have since determined to leave that section as is but in the future may request targeted changes based on consensus between parties. ⁶⁶

CIRNA confirmed their support for this approach when questioned by the NWB's legal counsel during the Public Hearing as follows:

[Q]...it's my understanding that it's contemplated that the Qikiqtani Inuit ·Association, the Applicant, and Crown-Indigenous Relations and Northern Affairs Canada are contemplating entering into a security management agreement after this hearing closes but before the Minister's decision is rendered, and the question that raises for the Board is simply confirmation that at this hearing and for this application, no changes are contemplated or requested by the parties to the existing security provisions under Part C and Schedule C of the licence.

[A] CIRNAC believes that all parties working together in good faith to finish the SMA, we do not expect any changes to Schedule C...⁶⁷

The QIA confirmed their support for this approach as well:

On the issue of security, QIA confirms that we are committed to negotiating a security management agreement with the Government

of Canada and Baffinland. We share Baffinland and Canada's desire for that work to be completed in time for the Minister's decision on the licence.⁶⁸

Part D: Conditions Applying to Construction and Operations

The scope of the Renewal Application includes the construction of engineered facilities and infrastructure for the Mary River Project site. The Board has a condition requiring the Licensee to submit to the Board for review for-construction drawings for all engineered facilities and infrastructure designed to contain, withhold, divert or retain waters and waste, sixty (60) days prior to the construction under the Renewed Water Licence.

Item 5 of the Existing Licence lists the Plans that were approved by the Board with the issuance of this Renewed Water Licence, or were carried forward from the Existing Licence. Baffinland proposed relocating the list of approved plans from Item 5 to a new Schedule K. The Board decided not to add a new schedule to remain consistent with its standard practice. The list, however, is now removed from Part D as it was redundant with Part B Item 14.

Item 7 in Part D requires the Licensee to inspect daily, the areas of the Mary River Project site affected activities during the Construction, Operations and other phases of the project, including the Early Revenue Phase, for signs of erosion. Baffinland proposed to update the requirement of daily inspections to weekly inspections during operations and other phases of the project including closure. The QIA noted that in their view any areas where work is ongoing should be subject to inspections, and that weekly inspections for erosion and sedimentation may be too infrequent, resulting in prolonged effects pathway that is mitigatable. Baffinland proposed to revert back to original language to address QIA's comment. The Board also agrees with the QIA's position on this and retains the frequency of inspections to daily.

The Board has updated the condition in Part D, Item 18 (Item 16 of the Renewed Water Licence) that requires the Licensee to conduct inspections of earthworks and geological and hydrological regimes, by changing the frequency of inspection from biannually to annually. This is consistent with the correspondence⁶⁹ issued by the Board on September 20, 2024, in response to a request submitted by Baffinland regarding change of frequency of geotechnical inspections.

The remainder of the revisions to the Part D, the Conditions Applying to Construction and Operation section ensure that the terms and conditions of the Renewed Water Licence under

this Part are consistent with the other type A water licences applicable to Mining Undertakings previously issued by the NWB.

Part E: Conditions Applying to Water Use and Management

Section 11 of the NWNSRTA states "... no person shall use, or permit the use of, water in Nunavut except in accordance with the conditions of a licence."

In the Draft Water Licence Framework, Baffinland suggested changes to Item 5, that allows the Licensee to recycle and use reclaimed water from approved facilities if such waters meet appropriate discharge criteria, by adding the exception of TSS if the water is being used for dust suppression. ECCC provided the following recommendation in response to the proposed change by Baffinland:

ECCC recommends that water that does not meet all discharge criteria, including TSS, should only be used for dust suppression in areas where runoff does not have the potential to enter the aquatic receiving environment.

This was further discussed between both parties during the Public Hearing and the language was updated accordingly. The Board has updated this condition to reflect changes proposed by both Baffinland and ECCC.

Item 10 requires the Licensee to update or revise annually following the commencement of the Operations Phase and/or the Early Revenue Phase, the Project Block-flow Diagram Water Supply Balance information for the various Project sites provided with the Application, and submit the revisions, for review by the Board, with the Annual Report under Part B, Item 2. Baffinland suggested changes to this condition requiring the Project Block-flow Diagram Water Supply Balance information to be updated or revised if required in the opinion of a Professional Engineer due to construction or operational changes that occurred within any given year, instead of annual updates or revisions. ECCC noted that the proposed changes do not clarify this condition and recommended keeping the original condition. The Board agrees with ECCC's position and hence retained the original condition without any changes as suggested by Baffinland.

Item 17 requires the Licensee to designate an area for the deposition of excavated and stockpiled materials that is at least thirty-one (31) metres above the ordinary High Water Mark of any water body. Baffinland suggested to update this condition by adding *unless otherwise approved by the Board in writing*. ECCC recommended that activities such as the deposition of debris or sediment does not occur within the thirty-one (31) metres minimum setback distances from water bodies, which is a standard practice for projects in Nunavut. Baffinland responded by adding that there may be site specific circumstances that may favour approval of reduced setbacks, and including this language would allow justifiable adjustment



of setbacks on Board approval. The Board is of the opinion that the addition of the language to this condition as suggested by Baffinland is not necessary and hence keeping it unchanged.

Item 23 has been updated to add requirement for the Licensee to provide details regarding water bodies that will be withdrawn from, the projected volume of water, and aquatic habitat information collected at the proposed water intake sites, at least sixty (60) days prior to construction. This shall be submitted to the Board as part of the design construction report.

The Board has included a condition as Item 27, based on concerns raised by different parties and commitments agreed between respective parties and Baffinland, requiring the Licensee to make updates to the SWAEMP as follows:

- Update the SWAEMP with a synthesis of the groundwater activity on site, combined with the groundwater quality analysis and interpretation. It is anticipated the update will include; frequency of upgradient and downgradient monitoring at selected shallow groundwater monitoring locations and identify potential areas and triggers associated with implementation of monitoring at the Project for water quality analytes and the associated monitoring frequencies. This requirement is based on the commitment by Baffinland in response to technical comment CIRNAC-R-22.
- Update the water sampling and monitoring location figures within the next version of the SWAEMP. This update will include updated water monitoring locations and flow directions. This requirement is based on the commitment by Baffinland in response to technical comment QIA-TR-20.
- Include the list of total and dissolved fractions in the next update to the SWAEMP, within 6 months following the approval of the Renewed Water Licence. This requirement is based on the commitment by Baffinland in response to technical comment by ECCC (ECCC-TC-04).
- Include a summary table with all proposed watercourse crossings (road and rail culverts and bridges) in the next update to the SWAEMP for crossing locations along the Tote Road. The review of the SWAEMP will occur following the NWB normal course of annual reporting, which occurs in parallel with the renewal process, within 6 months following the approval of the Renewed Water Licence. This requirement is based on the commitment by Baffinland in response to technical comment by DFO (DFO-TRC-01).

The remainder of the revisions to the Part E, the Water Use and Management section ensure that the terms and conditions of the Renewed Water Licence under this Part are consistent with the other type A Water Licences applicable to Mining Undertakings previously issued by the NWB.



Part F: Conditions Applying to Waste Disposal and Management

In the Draft Water Licence Framework, Baffinland identified the need to make corrections to the list of monitoring stations for the discharge directly into fresh water bodies form the Sewage Treatment Facilities including the Polishing Waste Stabilization Ponds. Item 17 has been updated accordingly to reflect correct monitoring stations which are MS-01, MS-01A, MS-01B, MS-MRY-04, and MS-MRY-04A.

ECCC recommended (ECCC-TC-06) during the technical review stage that more recent Federal Environmental Quality Guidelines (FEQGs) should be considered in developing discharge criteria for benzene, toluene, ethylbenzene and xylene (BTEX) for the Project. Baffinland in their response agreed to the recommendation and made the following updates in the Draft Water Licence Framework to reflect revised maximum concentration values for Grab Sample (mg/L):

- Item 17 Table 5: Effluent Quality Discharge Limits for Sewage Treatment Facilities to Freshwater Receiving Environment
- Item 19 Table 6: Effluent Quality Discharge Limits for Oily Water Treatment Facilities
- Item 20 Table 7: Effluent Quality Discharge Limits for the Landfill Facilities
- Item 21 Table 8: Effluent Quality Discharge Limits for the Bulk Fuel Storage Facilities
- Item 22 Table 9: Effluent Quality Discharge Limits for the Landfarm Facilities
- Item 23 Table 10: Effluent Quality Discharge Limits for Open Pit, Stockpiles, and Sedimentation Ponds

Baffinland proposed to remove or revise Item 18 of the Existing Licence to reflect that the NWB does not regulate ocean discharge. QIA recommends this condition remains within the Licence. Baffinland further noted that the NWB does not regulate discharge to the marine environment section and if retained, non-mandatory language shall be used so that it aligns with the NWB's mandate. The Board decided to remove this condition as it is outside the Board's mandate and the Board also understands that there are other bodies that regulate the discharge of waste to the oceans. This is also consistent with the Board's more recent practice with other type A water licences.

The Board has updated Item 24 (Item 23 in the Renewed Water Licence) as suggested by Baffinland to update the infrastructure and monitoring stations reflecting current site conditions. The updated monitoring stations include: MS-06, MS-07, MS-08, MS-09, MS-10, MS-11 and SP-07.



Item 25 has been removed and integrated into Item 24 (Item 23 in the Renewed Water Licence) Table 10: Effluent Quality Discharge Limits for Open Pit, Stockpiles, and Sedimentation Ponds as suggested by Baffinland to avoid duplication. The Board also removed Item 26 and Table 11 as requested by Baffinland stating that there are no facilities that would apply to Table 11 and not to Table 10 hence redundant. QIA inquired whether discharges from the KM105 pond and water management structures would be subject to referenced criteria. Baffinland confirmed that discharge at MS-11, which is currently the KM105 pond, is captured in Table 10 Effluent Quality Discharge Limits for Open Pit, Stockpiles, and Sedimentation Ponds, and the water management structures are now explicitly listed in Item 23.

The Board has included another condition as Item 27 requiring Baffinland to undertake a pit water quality model update in 2025 (Q4). This model shall include the following:

- Operational pit water quality predictions for the next 5 years (2025-2029)
- Water quality predictions for an early closure scenario at the end of 2029, considering three different climate change scenarios for a 100-year period.

This condition resulted form commitment by Baffinland in response to technical comment by CIRNA (CIRNAC-16).

The remainder of the revisions to the Part F: Waste Disposal and Management ensure that the terms and conditions in this Part of the Renewed Water Licence are consistent with other type A water licences applicable to Mining Undertakings previously issued by the NWB.

Part G: Conditions Applying to Modification

There were no substantive revisions to Part G, with all terms and conditions of the previous Water Licence being carried over with minor edits and updates.

Part H: Conditions Applying to Emergency Response and Spill Contingency Planning

The development and implementation of measures to respond to spills and other emergencies are fundamental to ensuring that any potential unpredicted adverse effects on the environment from Project activities are prevented and/or minimized. Accordingly, the Applicant submitted the *Spill Contingency Plan*, dated June 2024, and the *Emergency Response Plan*, dated June 2024, as part of the Renewal Application. These Plans identify potential emergencies that could arise while carrying out the undertaking and provide a procedural framework for responding to those emergencies.

There were no substantive revisions to Part H, with all terms and conditions of the Existing Water Licence being carried over with minor edits and updates.

Part I: Conditions Applying to General and Aquatic Effects Monitoring

As previously noted, s. 73 of the *NWNSRTA*⁷⁰ requires the NWB to set conditions at least as stringent as conditions prescribed by regulations pursuant to ss. 36(5) of the *Fisheries Act*, R.S.C. 1985, c. F-14. Furthermore, for the purpose of ensuring compliance with the Water Licence or regulations, an Inspector designated by the Minister may inspect or examine works, waters or waste and exercise other powers according to the *NWNSRTA*⁷¹. For the purpose of monitoring, the NWB may include conditions in the licence regarding monitoring programs to be undertaken.⁷²

The following monitoring plans were included as part of the Renewal Application:

- Aquatic Effects Monitoring Plan (AEMP), June 2024;
- Environnemental Protection Plan, June 2024; and
- Sampling Program Quality Assurance / Quality Control Plan, June 2024.

In this Part of the Renewed Water Licence, the NWB directs the Applicant to undertake the updated Monitoring Program described in Schedule I of the Renewed Water Licence and to measure and record monthly quantities of water used from various sources and of waste produced. In addition, the Board included conditions requiring the Applicant to update the AEMP to align with CCME standards, inclusion of event-based water quality monitoring, and addition of quantifiable triggers.

The QIA in their comments on Draft Water Licence Framework recommended the use of 'Engineer' instead of 'Professional Engineer' or 'Geotechnical Engineer'. While the Board has accepted this recommendation by QIA and made changes to Part I, Items 9 and 10, the Board also acknowledges that some infrastructure may require geotechnical inspections by law.

The Board has included a condition as Item 14, based on concerns raised by different parties and commitments agreed between respective parties and Baffinland, requiring the Licensee to make updates to the AEMP within 6 months of the approval of the Renewed Water Licence as follows:

• Incorporate updated industry standard guidelines and utilizing them to protect potential receiving environments down gradient of the Project. Licensee to add the new total Aluminum FEQG to the AEMP pending ongoing analysis of baseline data. The AEMP benchmark to be updated to align with CCME standards in the 2025

AEMP Rev 2 submission for selenium. This requirement resulted from commitment by Baffinland in response to technical comment by ECCC (ECCC-TC-11).

- Include event-based water quality monitoring informed by the QIA-TR-1 memorandum conclusions, or other relevant data. The AEMP will define how an event is triggered and assessed. This requirement resulted from commitment by Baffinland in response to technical comment by QIA (QIA-TR-2).
- Update the AEMP to provide quantifiable triggers (e.g., exceedances of water quality guidelines or AEMP benchmark values) within the framework. These triggers will lead to specific adaptive management actions to be undertaken in response to exceedances. The management actions for these cases shall be initially investigative following a process defined in the AEMP, and if the investigation determines it, appropriate mitigative actions for the source or the cause of these exceedances will be implemented. This requirement resulted from commitment by Baffinland in response to technical comments by QIA (QIA-TR-11/17).

The Board also included a new condition as Item 15, requiring the Licensee to submit to the Board for review a one-time memorandum within six (6) months following approval of the Licence. This memorandum shall include the following aquatic monitoring information:

- Temporal plots of water quality results from lake and stream CREMP monitoring areas that include results from the baseline (2006 to 2013), construction (2014), and operations (2015 to 2024) periods for specific parameters associated with the mine site ore bodies or with blasting (i.e., aluminum, arsenic, cadmium, chromium, copper, iron, lead, nickel, zinc, nitrate, nitrite, total Kjeldahl nitrogen, and ammonia). Area specific predictions from the Final Environmental Impact Statement (FEIS; Baffinland 2012) should be included on the plots for comparison;
- Tabular summaries of seasonal averages;
- A statement comparing the concentrations to area specific predictions from the FEIS;
 and
- Weather data corelated with sampling to the extent possible to assess the impact of wet versus dry events on observed monitoring values.

This condition resulted form commitment by Baffinland in response to technical comment by QIA (QIA-TR-1). The Board expects that as committed by Baffinland (commitment 31), the memorandum will be provided to QIA 30 days before submission to the Board to allow QIA to evaluate the conclusions and provide recommendations of updates into suggested management plans. Based on the review of the memorandum, the outcomes of the memorandum will be integrated into relevant management plans.



Baffinland suggested in the Draft Water Licence Framework that the term 'surface runoff' should be replaced with Contact Water as the later has been defined under the Licence. The Board has replaced the term surface water with Contact Water in Item 23.

Other revisions to the Part I with respect to Monitoring ensure that the terms and conditions of the Renewed Water Licence under this Part are updated for the Renewed Licence and are consistent with the other type A water licences applicable to Mining Undertakings previously issued by the NWB.

Part J: Conditions Applying to Abandonment, Reclamation and Closure

The Board requires all type A water licence holders to prepare an Interim Closure and Reclamation Plan, and, eventually, a Final Closure and Reclamation Plan in accordance with the *Guidelines for the Closure and Reclamation of Advanced Mineral Exploration and Mine Sites in the NWT (2013)* (Guidelines)⁷³ and consistent with the *Mine Site Reclamation Policy for Nunavut, 2002* (Policy).⁷⁴

As clearly outlined by the Board in the Shear Diamonds Licence Renewal Decision:

The Board's approach to reclamation reflects the four main objectives outlined in the Policy:

The Mine Site Reclamation Policy ⁷⁵ *for Nunavut serves four main objectives:*

- 1. Ensure the impact of mining on the environment and human health and safety is minimized;
- 2. Reduce the environmental liability that falls to government to the greatest extent possible;
- 3. Provide industry and the public with a clear signal of the government's expectations; and
- 4. Build positive and supportive relationships with the new regulatory authorities coming into operation in the North. ⁷⁶

With respect to the specific components of the plans, in the Licence the Board has maintained the approach put forward in the *Guidelines* that recognizes that there are three stages in the development of a Closure and Reclamation Plan (CRP). The first stage involves the preparation of a Preliminary Closure and Reclamation Plan that is typically prepared as part

of the environmental assessment of the project that demonstrates "how the mine site is proposed to be reclaimed and describes the likely residual risks to human health and the environment". The second stage involves the development of one or more Interim Closure and Reclamation Plans (ICRP) through the operating life of the mine, which builds on the Preliminary CRP, and is updated to reflect significant changes to the mine plan or key milestones in terms of the mine life.

As stated in the Guidelines:

The general purpose of the Interim CRP is to update preceding plans according to the current mine operating plan, updated or renewed community values, or advances in mine reclamation technology. Interim Reclamation Plans provide conceptual detail on the reclamation of mine components, which will not be closed until near the end of the mining operations, and operational detail for components which are to be progressively reclaimed earlier in the mine life. The Interim CRP should include increased detail and more specific closure criteria regarding reclamation components as these become available and as those areas of the mine are developed (e.g. rock piles that are completed or reclamation test studies that have been conducted).⁷⁷

The third stage involves the preparation of a Final CRP that should be provided and approved before a scheduled permanent closure takes place, or as soon as is practical after an unplanned closure. The general purpose of the Final CRP is to provide complete details, usually for regulatory approval, regarding the proposed reclamation activities such that they can be subsequently implemented⁷⁸. The Licence requires the filing of a Final Closure and Reclamation Plan at least twelve (12) months prior to the closure of the mine.

In compliance with these requirements, Baffinland submitted an updated *Interim Closure* and *Reclamation Plan (ICRP)*, Rev 6, dated November 2024, as part of the Annual Security Review Process (not as part of the Renewal Application) that is still under review by the Interveners. It is important to note that with the issuance of this Licence, the version of the ICRP as approved under Part B, Item 14 of the Licence is the ICRP (BIM-5200-PLA-0026, Rev 5), dated October 2018. While the Board recognizes that some of the recommendations and concerns raised by parties during the renewal process may be already addressed within the ICRP Rev 6, the Board acknowledges that Baffinland has committed to updating the ICRP by November 2026 based on their commitments. Therefore, given the fact that an

updated ICRP will be submitted to the Board as per Part B, Item 15, the Board will not necessarily approve the ICRP Rev. 6 at this time.

Part J Item 1 lists requirements for updates to the ICRP. The Board has updated this Item requiring Baffinland to include multiple climate change projections (SSP1, SSP2 and SSP 5) in the next update of the thermal model planned for November 1, 2026, as outlined in the Interim Closure and Reclamation Plan (ICRP), Revision 6. The Board also added requirement for Baffinland to update the ICRP to include soil or sediments containing site related contaminants that pose a risk to human health and/or the environment. The definition of contaminant was agreed upon by Baffinland and CIRNA as any substance that, when introduced into the air, water, soil or sediment, exceeds an agreed upon end land use or other criteria developed as part of the closure planning process and has the potential to cause adverse effects to human health, the environment or ecological systems.

The Board has included a requirement that Baffinland must notify the Board in writing, as soon as practically possible, and in any event, at least sixty (60) days prior to entering into a Care and Maintenance Phase. A Care and Maintenance Plan shall also be submitted to the Board within thirty (30) days of Baffinland providing such a notification of intent, and the Plan shall detail the Licensee's plans for maintaining compliance with the Terms and Conditions of the Licence during Care and Maintenance.

The remainder of the revisions to Part J regarding Abandonment, Reclamation and Closure ensure that the terms and conditions of the Renewal Water Licence under this Part are consistent with the other type A Water Licences applicable to Mining Undertakings previously issued by the NWB.



Schedules A through J

The Schedules in the Renewed Water Licence provide instructive detail to the conditions appearing in more general terms in the main body of the Water Licence and are spelled out in this format for greater clarity and as an aid to interpretation for the Licensee. Except for Schedule A, the Schedules provide, if needed, specific requirements for plans or reports to be submitted to the Board.

If the Board subsequently determines that an item in any of the Schedules requires revision in order to better reflect the intent and objectives of the renewed Licence, the Board may at its discretion, and upon consulting and providing written notice to the Licensee and intervening parties, revise the Schedule. Unless the Board directs otherwise, such revisions may not necessarily be considered as an Amendment to the Licences.

Schedule A: Scope, Definitions and Enforcement

Most of existing definitions in Schedule A were carried over from the previous Water Licence with slight modifications to keep these definitions up to date.

Schedule B: General Conditions

Schedule B outlines general and specific annual reporting requirements for the Mining Undertaking. Requirements in Schedule B were carried over from the existing Water Licence with some new additions.

As referenced above in the discussion of revisions to Part B, Item 17 to ensure the Licensee identifies and incorporates relevant IQ (both Inuit Qaujimajatuqangit and Inuit Qaujimaningit) studies and the results of any Inuit-led or community-based monitoring in relation to the licensed undertaking and within the scope of activities in the Water Licence, Baffinland proposed two additions to the annual reporting obligations as set out in Schedule B. Baffinland's suggested additions were as follows and were also supported by the QIA.⁷⁹

Schedule B Item 26 new addition:

26. a summary of results relevant to water use and management/waste disposal and management generated by QIA-led monitoring programs (such as the Inuit Stewardship Program) together with a summary of any agreed actions to be taken by the Licensee in response (including plan updates), where such monitoring results are provided in final to the Licensee by QIA at least 5 months prior to the Annual Report deadline.

Schedule B Item 44 new addition:

44. a summary of results relevant to water use and management/waste disposal and management generated by QIA-led studies (such as the Inuit Stewardship Program) together with a summary of any agreed actions to be taken by the Licensee in response (including plan updates), where such studies are provided to the Licensee by QIA in final at least 5 months prior to the Annual Report deadline.

The Board agrees that these recommended additions to the annual report will provide transparency and accountability to the Board, interested parties and the public to ensure that the QIA-led studies are identified and details regarding incorporation are provided by the Licensee. However, as expressed by Baffinland during the Public Hearing, the QIA-led monitoring programs may not be the only source of relevant IQ or Inuit-led or community-based monitoring activities that may arise during the term of the Renewed Water Licence:

...Baffinland supports the Inuit stewardship program and understands it is a valuable initiative to add to the existing multifaceted programs to incorporate Inuit feedback and Inuit Qaujimanituqangit [sic Qaujimajatuqangit] into our project. Those include engagement with the Qikiqtani Inuit Association and other Inuit organizations through the Nunavut Impact Review Board and Nunavut Water Board regulatory processes, Baffinland community engagement programs, the Oaujimanituqangit framework, our adaptive management plan, and full-time Inuit staff positions in each community dedicated incorporation of Inuit Qaujimanituqangit and the project. 80

Consequently, the Board has broadened the language in the two additions to Schedule B to ensure that the Licensee is not limited to only identifying when relevant IQ and monitoring results have been led or provided by the QIA, but also if this knowledge and monitoring information is shared via other parties, programs or initiatives. To ensure the same transparency and accountability mechanism exists for all relevant IQ and Inuit and community-led monitoring initiatives, the Board has modified the recommended additions to Schedule B as follows:

Schedule B Item 26 new addition as revised by the Board (additions to the wording in Exhibit 14 shown in underlined text):

26. a summary of results relevant to water use and management/waste disposal and management generated by QIA-led monitoring programs (such as the Inuit

Stewardship Program), or other relevant IQ studies, Inuit or community-led monitoring initiatives, together with a summary of any agreed actions to be taken by the Licensee in response (including plan updates), where such monitoring results are provided in final form to the Licensee by QIA, or other individuals or organizations responsible for the studies or initiatives at least 5 months prior to the Annual Report deadline.

Schedule B Item 44 new addition (additions to the wording in Exhibit 14 shown in underlined text):

44. a summary of results relevant to water use and management/waste disposal and management generated by QIA-led studies (such as the Inuit Stewardship Program), or other relevant IQ studies, Inuit or community-led monitoring initiatives together with a summary of any agreed actions to be taken by the Licensee in response (including plan updates), where such studies are provided to the Licensee by QIA, or other individuals or organizations responsible for the studies or initiatives in final form at least 5 months prior to the Annual Report deadline.

The Board also added a requirement for the Licensee to include a table providing the status of management plans in the recurring annual reports for Operations. This requirement resulted from commitment made by Baffinland in response to technical comment by CIRNA (CIRNAC-R-1).

The Board included another requirement for the Licensee to conduct a review of dustfall data and the associated monitoring program to assess sample design, program assumptions, data collection, and dustfall relative to baseline predictions, as part of the 2025 Annual Report for Operations, to be submitted by March 31, 2026. The outcomes of this review to be integrated into relevant management plans. Any plan updates are required to be completed within 6 months of publication of the dustfall data review.

Schedule C: Conditions Applying to Security
