On January 22, 2020 the Nunavut Impact Review Board (NIRB or Board) received the ministers response to the Board's Reconsideration Report and Recommendations regarding Agnico Eagle Mines Limited's Whale Tail Pit Expansion Proposal, accepting the Board's recommendation that the project can proceed with revisions to specific Terms and Conditions as well as the issuance of new Terms and Conditions for Project Certificate No. 008. As a result, the NIRB is required to issue an amended Project Certificate within 30 days, and has proposed to host a Project Certificate workshop to assist in finalization of the Project Certificate. Having considered the availability and intended participation of parties, the NIRB is scheduling the Project Certificate workshop by teleconference for the afternoon of February 5, 2020.

The Project Certificate workshop aims to bring parties together to facilitate discussions on the implementation of the new and revised terms and conditions of the Project Certificate into their respective licences, certificates and permits. The workshop provides an opportunity for regulatory authorities to provide confirmation regarding which terms and conditions will be implemented by each department or agency. The workshop agenda is provided **Appendix A** of this letter.

Parties who have not yet provided the Board with confirmation of planned attendance at the Project Certificate workshop are required to provide the name, position, and regulatory jurisdiction of each representative to the NIRB via email to info@nirb.ca on or before February 3, 2020. In addition to the draft Project Certificate previously circulated, NIRB staff will be providing the teleconference information and presentation direct to parties prior to the start of the workshop.
