Notice is given that the Nunavut Impact Review Board (NIRB or Board) has scheduled an in person Public Hearing in respect of Agnico Eagle Mines Limited's "Whale Tail Pit Expansion" proposal, a proposed amendment to the approved Whale Tail Pit Project (NIRB File No. 16MN056). The Public Hearing is part of the NIRB's reconsideration of the terms and conditions of the Whale Tail Pit Project Certificate No. 008 under Article 12, Section 12.8.2 of the *Nunavut Agreement* and s. 112(1) of the *Nunavut Planning and Project Assessment Act*.

All proceedings will be open to the public and media and will be conducted with simultaneous English-Inuktitut interpretation, and upon advance request, English-French interpretation.

# **Participation:**

Parties wishing to participate as formal intervenors must submit a completed Intervenor Application (available from the NIRB) by **July 11, 2019**. Final written submissions to be considered at the Public Hearing must be received by the NIRB by **July 26, 2019**. During the Public Hearing any person who wishes to express their views may register with the Board on the day of the Hearing to share their spoken comments and questions during the portions of the Hearing set aside to hear the views of the public.
