On October 7, 2019, the Applicant provided responses to interveners' comments. The Applicant is advised to review all submissions, including intervening parties' comments on the technical review of the Application in preparation for the upcoming Technical Meeting and Pre-Hearing Conference.

As stated in its August 14, 2019 correspondence the Board directed the NWB staff to hold a Technical Meeting and Pre-hearing Conference (TM/PHC) in Baker Lake the week of October 28, 2019. On October 1, 2019, the NWB received correspondence from Agnico Eagle, requesting that the TM/PHC be conducted via teleconference. After careful consideration of the technical review comments provided by the intervening parties and the Applicant's responses³, the Board concluded that holding the TM/PHC in-person in Baker Lake would be appropriate. Therefore, the NWB advises the parties that <u>Tuesday</u>, <u>October 29, 2019 and Wednesday</u>, <u>October 30, 2019</u> are set as dates for the Technical Meeting and Pre-hearing Conference, respectively, at the Community Hall, Baker Lake, Nunavut.

In preparation for the TM/PHC, the Board has attached a copy of a draft Agenda and requests that interested parties provide relevant comments to the NWB's Licensing Department at licensing@nwb-oen.ca by 3:00 p.m. MT, Friday, October 18, 2019. In addition to comments on the draft Agenda, interested parties are asked to also provide the following information along with their submissions:

- Confirm the attendance of their organization, group or individual;
- Provide the names of the individuals who will be participating on their behalf in the TM and PHC respectively; and
- Identify whether they wish to make a formal presentation of their submissions during the Technical Meeting.

Following receipt of this information the NWB will distribute a final version of the Agenda in advance of the TM/PHC, as well as the names of the participating organizations and/or persons who have confirmed their attendance.

The Applicant and intervening parties intending to make presentations during the TM/PHC must provide to the NWB, for public distribution and posting on the Board's registry, copies of their presentation materials (including the Applicant's and interveners' presentations). These materials

should be provided in English and Inuktitut along with executive summaries also in French, preferably in PDF/PowerPoint format, no later than <u>3:00 p.m. MT, October 18, 2019</u>. It should be noted that intervening parties are expected to indicate during their presentations whether the issues that they have identified were or will be addressed by Agnico Eagle to their satisfaction prior to the Public Hearing (PH).

As part of this Agenda, the NWB is proposing to hold a community session in the evening of October 29, 2019 to allow residents of Baker Lake express views they may have regarding the Projects, the Applications, and/or ask any questions to the Applicant and the intervening parties. The Applicant and intervening parties should be prepared to provide summarized versions of their Technical Meeting presentations for the community session. To ensure that community members have access to the presentations in Inuktitut and English, paper copies of both versions of presentations should be made available for distribution during the community session.

In addition, the NWB requests that all parties bring with them the copies of the Application and correspondence/submissions (either hard copy or electronic) for reference as required, as the NWB will likely only have a few hard copies available for viewing and for the Public.
