Further to the NIRB's letter of August 31, 2017 respecting the Final Hearing for the NIRB's review of Agnico Eagle Mines Ltd.'s Whale Tail Pit Project Proposal, Agnico-Eagle is pleased to provide the following information and a request for an extension.

1. Request for Extension to File Digital Copies of Agnico-Eagle's Final Hearing/Community Roundtable Presentations to 9:00 am (EST) Sept. 11, 2017

Agnico-Eagle is requesting an extension of today's filing deadline of September 5, 2017 to 9:00 am EST to no later than 9:00 am (EST) Monday, September 11, 2017. Agnico-Eagle will copy all parties on its submission to the NIRB via email in order to ensure that the presentations are delivered promptly and there is an opportunity for all to review the Final Hearing Presentations well in advance of the commencement of the public hearing on September 19, 2017 in Baker Lake. Hard copies will also be hand delivered to the Baker Lake HTO office on September 11, 2017.

This extension is necessary in order to permit Agnico-Eagle sufficient time to review and respond to the Final Hearing Presentations filed on September 5, 2017 by other parties to this proceeding, and to revise its own presentations to address any remaining outstanding issues.
