As required, Agnico Eagle provided below a summary of the quarry clean-up activities and a summary of the maintenance that will be completed this year on water crossings to prevent further sediment from entering the water course.

**Meadowbank AWAR Quarry Lease 66A/8-72-5**

Agnico Eagle started the clean up of garbage and waste found in Quarries along the AWAR. As per your inspection report, there were non-compliance observed in Quarry 6, 8, 9, 11, 16 and 18. Photos below shows the clean up was completed on Quarries 8, 9, 11 and 18. Quarries 6 and 16 will be cleaned up by July 15<sup>th</sup>, 2021. Snow accumulation was still present in some of the quarries cleaned up and Agnico Eagle will ensure to return in each of them after complete melting to remove any remaining waste/garbage that may have been left behind.

**Whale Tail Haul Road Lease 66H/8-01-2**

Agnico Eagle has started the cleaned up of garbage and waste found in Quarries KM 145.5 and KM 167 along the Whale Tail Haul Road as per inspection report. Agnico will complete the clean up activities by July 30<sup>th</sup>.

**Meadowbank Water License 2AM-MEA1530 and 2AM-WTP1830**

Concerns were raised in the inspection report in regard to erosion and deposition of sediment into water along the AWAR bridges at KM 17, 23, 69, 74 and 83 and WTHR bridges at KM 131, 135, 138, 141, 148 and 160. As per the Water License requirement, Agnico is required to complete annually, a third-party geotechnical inspection along the AWAR and the WTHR. Following receipt of the inspection report, Agnico will implement any recommendation and control measures to prevent sediment and erosion from entering the watercourses.

As per our Freshet Action Plan, a daily inspection of all the water crossing on AWAR and WTHR was performed and no sediment issues were noted during the 2021 freshet at any water crossing.
